#### INTRODUCTION

The General Legal Council was established in January 1972 by the Legal Profession Act. Its statutory function is concerned with the legal profession and in particular the organization of legal education and the upholding of standards of professional conduct. By virtue of the Legal Education Act, the Council's function as the Legal Education Authority is vested in the Council of Legal Education which is established by Agreement among several Commonwealth Caribbean countries.

Apart from Law Officers of the Crown and legal officers of Government who are *ex officio* entitled to practise as such, no person can lawfully practise as an attorney who does not hold a practising certificate issued by the Council. Practising Certificates are issued annually on satisfying certain requirements, including the payment of an annual fee.

The Council is required to appoint from among its members or former members, Judges or retired Judges and attorneys of not less than ten (10) years standing, the Disciplinary Committee which adjudicates on complaints of misconduct by attorneys in any professional respect.

The Council is authorized to make rules prescribing the standards of professional etiquette and professional conduct for attorneys and to direct that any specified breaches of such rules constitute misconduct in a professional respect.

#### **CHAIRMAN'S MESSAGE 2021**

The Council's operations have returned to a semblance of normality notwithstanding the continuing COVID-19 Pandemic. Greater reliance has been placed on the use of technology such as video conferencing for the holding of meetings and CLPD seminars to great success.

To ameliorate the dislocation that has been caused to attorneys by the Covid-19 Pandemic, a number of CLPD seminars have been provided free of cost to assist attorneys in complying with the mandatory CLPD requirements. Further, the continuing support of the CLPD program by the Profession has permitted generation of sufficient surpluses to maintain the Council's operations without the need to seek an increase in practising fees, which have been maintained at the same level for the last five years.

At the end of January 2021, the Hon. C. Dennis Morrison P. (Ret.) demitted the chairmanship of the CLPD Committee. The Council extends its thanks to Justice Morrison for his contribution to the development of the program for continuing legal education and for his enlightened leadership of the Council's CLPD Committee. We also extend welcome to the Gillian Burgess who has assumed the mantle of chairperson.

A number of deficiencies have been apparent with operation of the Legal Profession (Accounts and Records) Regulations. A worrying trend has been that several attorneys who have misappropriated client money have nevertheless been able to submit unqualified annual accountant's reports. It was therefore evident that these reports were being treated as a proforma box ticking exercise rather than meaningful compliance reporting. In addition, a number of attorneys have submitted accountant's reports prepared by unqualified persons and, in at least one instance, the annual accountant's reports bore the purported signature of an accountant who had died some years prior to the date of the reports. To address these deficiencies, the Council has enacted the Legal Profession (Accounts and Records) (Amendment) Regulations 2021 (the Amended Accounting Regulations 2021) that will come into effect on the 1st day of January 2022.

The Amended Accounting Regulations 2021 require that a copy of a current practising certificate for the public/chartered accountant who prepares the annual accountant's report must be submitted with the report. The Amended Accounting Regulations 2021 also require the

accountant to expressly qualify the report and to separately notify the Council where serious

deficiencies/irregularities have been detected in the course of preparing the report. It is hoped

that these amendments will assist the early detection of irregularities to permit intervention by

the Council where necessary to safeguard client property.

Finally, the Amended Accounting Regulations 2021 will reduce the burden on attorneys with

small practices by permitting the filing of a declaration by the attorney in lieu of an accountant's

report where the trust money received by the attorney in any calendar year comprises fee

advances that do not exceed \$3 million in aggregate.

On 31st July 2020 the Court of Appeal delivered judgment finding that the anti-money laundering

reporting and monitoring regime applicable to attorneys under the Proceeds of Crime Act and the

AML Guidance issued by Council contravened the Constitution. The Council is pursuing an

appeal to the Judicial Committee of the Privy Council.

The Council supports the creation of a welfare fund to assist indigent attorneys particularly when

they become ill. A committee has been created to further this process. A CLPD presentation to

outline the options has been made to the Profession free of cost, a survey has been issued and

consultations are to be held with the Jamaican Bar Association and other regional associations

before making submission to Government for enactment of legislation to create such a fund.

I would like to thank the Staff, all Members of the General Legal Council and Members of the

Committees for their continuing support and commitment to the advancement of the Legal

Profession.

#### 6. ACCREDITATION COMMITTEE

- 1. During the period, April 2020 March 2021, the Committee received a total of 39 new applications from institutions for accreditation of courses to be presented by them and 1 application was submitted by the Law Faculty of the University of the West Indies for Provider status, which was approved. There were 135 applications for exemptions, 10 applications for extensions and 125 applications from individuals for credits for activities in which they had participated. Of the total of 310 applications which were reviewed during the period, 115 applications were successfully addressed, 43 were refused, and 152 were granted extensions.
- 2. The data also discloses that during that period, of a total number of **3,940** attorneys,
  - a. 770 are fully compliant in their participation in CLPD programmes,
  - **b. 1250** attorneys had participated in sufficient CLPD presentations to be awarded the requisite number of credits for compliance but had not submitted their Form 3 resulting in them being technically non-compliant, and
  - c. 1920 are partially compliant.

3. Attorneys have until November 2021 to become fully compliant. Sixteen (16) attorneys have received exemptions; One Hundred and Fifty-Two (152) received extensions.

The work of the Accreditation Committee continues to benefit from the conferral of provider status on three institutions as the Committee has been able to keep current with addressing the remaining applications.

#### 7. ADVERTISING REGULATORY COMMITTEE

- 1. <u>COMMITTEE MEMBERS</u>: The members of the General Legal Council's Advertising Regulatory Committee (hereafter "*the Committee*") during the year under review were as follows:

- **2. DATES OF MEETINGS**: For the period under review the Committee had a total of six (6) meetings, the number of meetings being affected by the state of affairs created by the Corona ("Covid-19") Virus. The following are the dates of the said meetings:
  - (a) June 23, 2020;
  - (b) September 1, 2020
  - (c) October 29, 2020;
  - (d) January 21, 2021;
  - (e) February 18, 2021; and
  - (f) March 18, 2021.

#### 3. MATTERS ADDRESSED DURING THE PERIOD UNDER REVIEW:

On a number of occasions the Committee had to contact, or write to, a number of persons regarding various matters including the following:

- (a) advertising on Social Media (in particular Facebook, Instagram and Twitter) in breach of the Canons. This was done largely by young counsel;
- (b) advising on overseas lawyers, not admitted to practise in Jamaica, advertising in Jamaica;
- (c) texts by Attorneys-at-Law sponsored by, or in "partnership" with, internet providers such as FLOW and Digicel;
- (d) ensuring that a billboard, advertising a law firm as "Specialists" without the necessary authorization or certification from the GLC, was removed;
- (e) ensuring that a law firm's billboard was of the appropriate dimension and properly placed on the building housing the law firm;
- (f) communicating with, and obtaining an apology from, legal counsel who appeared in a television advertisement promoting a financial institution while using her professional designation "Attorney-at-Law"; and
- (g) completing a legal opinion on whether the "*Bignall*" sign atop the building in which the law firm Bignall Law operates breaches the Canons, especially those dealing with advertising.

#### 4. JOINT PAPER ON THE CANONS OF THE LEGAL PROFESSION

In July, 2020 the Chairman and member Mikhail Jackson collaborated on a comprehensive presentation - "Social Media Advertising For Lawyers: Ethical Lessons – What Do Our Canons Say?". This covered the history of the Canons starting with the 1972 iteration and spanning roughly fifty years since the promulgation of the Legal

Profession Act. This paper was well- received and was done in conjunction with the Jamaican Bar Association, presented on July 26, 2020 during the Bar's annual mid-year conference held virtually.

5. SPECIALIZATION CRITERIA COMMITTEE ("SCC"): This body continued its work in deciding on the criteria, the relevant forms and the procedure for Attorneys-at-Law to apply to become experts or specialists in various fields of law practice. At the time of writing this report the SCC had received only recently the last outstanding contribution from the Cornwall Bar Association and was finalizing its report to the GLC with its recommendations.

#### **<u>6. PLANS FOR THE COMMITTEE</u>**:

Heading into the next year the Committee intends to do the following:

- (a) reviewing its membership to ensure that there is a good balance of experienced practitioners and young counsel to ensure succession planning;
- (b) continuing to assist the GLC in any way possible including, in particular, the matters involving Mr. Vaughn Bignall and the Bignall Law firm;
- (c) assisting the SCC to complete its work so that the proposed provisions regarding certifying lawyers as "experts" and "specialists" can be enacted and implemented;
- (d) continuing to review the Canons and the most recent "Guidelines", particularly the provisions dealing with advertising; and
- (h) arranging another seminar dealing with the provisions of the Canons regarding advertising. This proposed seminar will be targeting young counsel in particular with guidance to be provided re advertising on Social Media.

#### 8. INFORMATION TECHNOLOGY COMMITTEE

During the financial year April 1, 2020 – March 31, 2021, the General Legal Council continued to retain the consultancy services of Ms. Bertina Macaulay and Mr. Sean Williams to handle its Information Technology requirements.

Mr. Ackeem Anglin one of the Council's administrative assistants, has continued to provide an increased level of in-house IT support, particularly by interfacing with members of Council and

its various sub-committees to efficiently arrange the significantly increased video conferences required since the advent of the covid-19 pandemic to carry out the business of Council.

During the financial year under review, the General Legal Council's information technology operations were enhanced as follows:

- i) Continued application of the CURIA Court Management Software to significantly improve the Disciplinary Committee's administration, documentation and case management activities; this has assisted in substantially reducing the backlog of outstanding disciplinary matters;
- ii) Continued use of laptop computers by the Disciplinary Committee's administrative staff to prepare verbatim notes of evidence at all Disciplinary Committee hearings therefore resulting in a marked improvement in the accuracy and delivery time of the notes of evidence related to the disciplinary hearings;
- iii) Integrating teleconferencing and video link facilities for Council meetings, various subcommittee meetings and Disciplinary Committee hearings, which has facilitated committee members, attorneys and complainants who are unable to personally attend meetings, or the disciplinary hearings.
- iv) All CLPD seminars have continued to be made available by webinars whether streamed live or by recorded material.

#### 9. PROTECTION OF CLIENTS' ASSETS COMMITTEE

The following comprise the matters that have been addressed or are being addressed by the committee:

#### CAROL VASSAL

- The sum of **J\$6,587,159.11** collected on behalf of clients was deposited to the Accountant General on July 5, 2019 and are still being held at its treasury.
- The position remains the same with respect to the client files that were retrieved by the Council. That is, the Government Archivist, despite the Court Order directing her to receive and store the client files, has responded that there is not enough room to offer storage at this time. The files thus remain in the Council's possession and are still being issued to clients who may occasionally visit the Council with claims.
- All remaining Duplicate Certificates of Title have been removed from the files and sent to the Registrar of Titles. Registrar, Miss Cherise Walcott confirmed receipt of these on the 12th day of June, 2020.

#### **LANZA TURNER-BOWEN:**

- The files of Lanza Turner Bowen were reviewed by Miss Deanna McFarlane and Miss Tony-Ann Smith, Attorneys-at-Law who were employed to go through the files of Mrs. Turner-Bowen. It was a necessary task as these files came without an index or accounting reports. An excel sheet was created with a listing of all files in the Council's possession with contact numbers and addresses if they appear on the file. This exercise assisted us to ascertain what we have in our possession and it has made it easier for the committee to return files to her former clients when called upon to do so. It also allows us to be more pointed in our efforts to have these files returned to clients.
- The matter was referred to the Office of the Supervisor of Insolvency for consideration 'whether the Government Trustee could be appointed as Trustee for the estate of Lanza Turner-Bowen and the Supervisor thereafter undertake administration'. However, the Supervisor of Insolvency, has offered grounds upon which he believes he is not the appropriate body to administer the client files.
- Further advertisements were published on January 28 and February 2, 2020 in the Gleaner and Observer Newspapers and Clients continue to present date to claim files which are returned.
- The following funds were received from Sagicor Bank and Harrison and Harrison, Attorneys-at-law:

#### **SAGICOR BANK:**

- 1. One Hundred and Seventy-Five Thousand and Ninety-One Dollars, Ninety-Four Cents (J\$175,091.94)
- 2. Three Thousand Four Hundred and Thirty-One Dollars and Sixty-Three Cents (US\$3,431.63)

#### HARRISON AND HARRISON, ATTORNEYS-AT-LAW:

3. Two Hundred and Fifty Thousand Dollars (\$250,000.00) from Harrison & Harrison, Attorneys-at-Law.

The Council holds a total of Nine Hundred Thirty-nine Thousand, Eight Hundred and Thirty-six Dollars and Forty-four Cents (\$939,836.44) in a trust account operated by the Council.

• Thus far the Council has received monetary claims in the amount of Twenty Seven Million, Four Hundred Thirty Eight Thousand, Six Hundred Forty Seven Dollars (\$27, 438, 647.00), which is far in excess of the sum collected from the deceased's clients' account. Below is a list of the monetary claims and the nature of each claim.

- As a result, the Council applied to the Supreme Court for directions. On the 25<sup>th</sup> day of March, 2021, Justice Mason heard the Fixed Date Claim Form filed on the 22<sup>nd</sup> day of December, 2020. After considering the arguments made on behalf of the Council, Justice Mason (Ag) made several orders, which the Council is currently in the process of complying with.
- To date, the cost to the GLC to administer this intervention is approximately one million dollars (\$1,000,000.00).

#### **LORRAINE MOORE:**

The circumstances of this matter remain the same:

- The Council intervened in the estate of Lorraine Moore, who died testate on August 25, 2019 and who was an Associate with the firm Dunbar and Company, Attorneys-at-Law.
- However, while so employed we were advised that she had conduct of two private
  matters: a conveyance matter and a personal injury matter. The firm took conduct of the
  conveyance matter and the GLC intervened for the purpose of protecting the client she
  represented in the personal injury suit.
- The matter concluded by way of settlement, the funds from the Insurance Company were dispersed to the Attorney's client account at First Global Bank. Said sum was not yet transferred to the client upon her death. The sum of One million Six Hundred Thirty Six Thousand, Seven Hundred and Eighty Two Dollars and Nine Cents (\$1,636,782.09) was

sent to Miss Moore's Client Account. This sum represents the settlement sum minus charges for electronic transfer.

- An amount of 25% of this sum, being Four Hundred and Nine Thousand, One Hundred and Ninety Five Dollars and Fifty Two Cents (\$409,195.52) was agreed between the deceased and the client to be paid as legal fees. This legal fee was held by the Council in a Trust Account while the balance of One Million Two Hundred and Twenty Seven Thousand, Five Hundred Eighty Six Dollars and Fifty Six Cents (\$1, 227, 586.56) was sent to the client's account.
- On the 27<sup>th</sup> of October, 2020, Beckford, Smith-Waite & Company presented to the Council a Grant of Probate, and resultantly, the Council has disbursed the legal fees to the firm on behalf of the Executor.
- The Conveyance matter has now been completed.

#### **OTHER MATTERS:**

It has been brought to our attention that the following Attorneys died, however, there has been no forthcoming claims requiring an intervention:

- 3. **Raymond Clough**: Ms Mireille Clough is now the executor of her father's estate. However, Maurice Long, surviving partner of the firm Clough, Long & Co is administering and handling all of Raymond Clough's files.
- 4. **Charlene James Jarret**: Miss Inga Samuda, attorney-at-law, is currently assisting the Council by returning client files to former clients of the deceased.
- 5. **Paul Beswick:** Mr. Beswick's daughters Angel and Wendy Beswick are now the managing partners of his firm and have continued its operation and thus have assumed conduct of the matters that were being handled by their father.

In addition, Miss Janet Patmore also continues to administer the client files of **Mr. Debayo Adedipe** who was struck from the Roll of Attorneys on October 23, 2019. She has advised that she will be sending a proper listing of the matters in the office to the Council as soon as possible.

#### 10. ACCOUNTING REPORTS COMMITTEE

During the year under review the Committee did the following:

- a) Reviewed the Legal Profession (Accounts and Records) Regulations, 1999 proposed amendments thereto in the form of the Legal Profession (Accounts and Records) (Amendment) Regulations, 2021 (the "Accounting Reports Regulations"). These Regulations sought to update the form of Accounting Reports to be prepared and submitted to the General Legal Council ("GLC") and to introduce a requirement for a notice to be sent to the GLC where in the course of his inspection of the books, records and accounts, the accountant has found deficiencies in compliance with the Accounting Reports Regulations. These Regulations were promulgated by the GLC on June 4, 2021 and will take effect on January 1, 2022;
- b) Considered several policy issues raised by attorneys and reviewed the Accounting Reports Regulation in order to provide guidance to management regarding the interpretation of the Regulations or the policy of the GLC towards the issue raised;
- c) Reviewed and responded to requests for exemptions and extensions;

Accountant's Reports or Declarations are generally due by June 30 each year for the preceding calendar year (unless an attorney has a different 12 month period as his/her financial year).

To date, the average percentage compliance for the years 2000-2020 is 91.37 %. Compliance for financial year 2019, is currently at 75.42%. and 2020 is 65.26%, however, we continue to receive accountant reports and declarations with respect to this year and anticipate that persons will make an effort to file reports or seek extensions before the end of the year to avoid being unable to obtain the practicing certificate for 2022.

The Accounting Reports Regulations empowers the GLC, where it is satisfied that the circumstances warranted it, to grant extensions of time to comply with the Accounting Reports Regulations. Additionally, the Regulations also empowered the GLC to grant exemptions from the requirements under the Accounting Reports Regulations for the delivery of an accountant's report or declaration to attorneys who are exclusively employed outside Jamaica for the period of such employment outside Jamaica.

During the period April 1, 2020 to March 31, 2021 there have been nine (9) applications for extensions which have been granted and ten (10) applications for exemptions which have been granted.

Pursuant to Regulation 16(6), the GLC withheld the issue of a practicing certificate to twenty-two (22) attorneys who had failed to comply with the Accounting Reports Regulations. Twelve (12) attorneys have since become compliant.

During the period April 1, 2020 to March 31, 2021 no new complaints were laid against attorneys for failure to comply with the Accounting Reports Regulations.

#### 11. FINANCE AND ACCOUNTING COMMTTEE

The Finance and Accounting Committee continued to guide, support and strengthen the Council's financial activities during the period April 1, 2020 – March 31, 2021.

The committee continued to provide proper, adequate and rigorous supervision and direction, specifically in matters concerning expense containment, financial transactions and prudent investment opportunities.

Among the many significant contributions made by the Committee during the period under review, was to assist the Chief Executive Officer to prepare the Council's annual revenue and expense budget.

Having recognized the continuing adverse financial and economic conditions of the international coronavirus pandemic, the Committee provided comprehensive and sound guidance and assistance for casting the Council's revenue and expense budget for the financial year April 2020 – March 2021.

The Finance and Accounts Committee also periodically monitored all financial inflows and outflows in accordance with the budgeted provisions, therefore ensuring that the Council's finances were carefully administered.

The Committee maintained a close working relationship with the Chief Executive Officer and by extension with the Council's external auditor to ensure that the Council's operational and reporting standards continued to be in line with the established accounting, financial and administrative procedures.

The Committee periodically monitored the Council's bank accounts and the associated commercial bank transactions and consequently recommended that the number of commercial bank accounts be rationalized on completion of the annual financial audit.

The members of the General Legal Council's Finance & Accounting Committee during the 2020/2021 financial year were, Messrs. Lowel Morgan (Chairman), Richard Ayoub, Stuart Stimpson, Stephen Shelton QC, Donovan Walker and a Chartered Accountant, Ms. Paula Turner.

# 12. <u>CONTINUING LEGAL PROFESSIONAL DEVELOPMENT (CLPD ) COMMITTEE</u> INTRODUCTION

- The annual report concerns the activities of the CLPD Committee of the General Legal Council for the period April 1, 2020 to March 31, 2021. In keeping with the objectives of the CLPD Committee to provide quality continuing legal education courses to attorneys in Jamaica, this report contains an account of the courses offered during the year under review and the participation of attorneys in these courses. It also contains aspirations of the committee to improve the customer experience of the attorneys and the impact of the courses.
- 2. April 1, 2020 marked the commencement of the eighth (8<sup>th</sup>) year that the CLPD Committee has been serving members of the legal profession in this capacity. The CLPD Committee of the General Legal Council was established in 2013 and has been offering courses in Continuing Legal and Professional Development since February 18, 2013. The Committee was chaired by the Hon. Mr. Justice C. Dennis Morrison since 2015. Justice Morrison demitted office in December 2020 and Miss Gillian Burgess assumed the chairmanship of the committee. It was a particularly challenging year because of changes in operations occasioned by safety protocols enacted by the Government of Jamaica because of the COVID-19 pandemic. The Committee is grateful to Justice Morrison for steering the committee through the challenges of 2020 and for his several years of service.
- 3. The Committee fulfilled its aim to meet at least once per month during term time. It has from time to time met more frequently as the need has arisen and for the period under review met a total of 8 times. The full membership of the Committee is shown in Appendix A.

#### **FUNCTIONS**

- 4. The scope of the Committee's work is:
  - i) To design and present courses for the purpose of the continuing legal professional development of Attorneys-at-law;
  - ii) To arrange programmes for the delivery of CLPD seminars on an island wide basis:
  - iii) To ensure that there are adequate offerings in Ethics and Client Welfare, Business Management and Finance.
- 5. In carrying out its functions, the CLPD Committee encourages the conduct of research in the preparation of papers on a variety of legal subjects. In the relevant period the Committee presented papers on topics such as Contracts, Conveyancing, Civil Practice

and Procedure, Regulatory Requirements, Employment, Taxation, Dispute Resolution. Regarding the mandatory requirements for presentations in Ethics and Client Welfare, Business Management and Finance, the Committee has also sought to ensure that there have been adequate offerings in these subjects.

- 6. Since March 2019, the Committee has been facilitating access to selected seminars using the internet. As a result of the restrictions on gatherings occasioned by the COVID-19 pandemic, the CLPD Committee courses were offered exclusively online. A total of Sixty-two courses were offered by Zoom a cloud-based videoconferencing software that permits virtual meetings. Ten (10) courses were offered at no cost to the participants in May 2020 to ensure that attorneys could complete their CLPD requirements despite the financial hardships which resulted from the economic contraction caused by the COVID-19 pandemic and as an expression of gratitude for the support of the profession as we strive to improve. Five of these sessions were offered in collaboration with the CCJ Academy of Law.
- 7. Courses offered at no cost were;

Genera Legal Council

- Data Protection and Covid 19
- The Liberty of the Subject in a Pandemic
- Covid-19 and the case for Occupational Health in Jamaica: Balancing life, livelihood and profit
- Protection of Clients' Assets
- What do you need to know about the General Legal Council's Compensation Fund?

CCJ Academy of Law in collaboration with the General Legal Council

- Law Practice and technology in the Covid 19 Context
- Administration of Justice
- Force Majeure and Commercial Contracts
- International Law
- Civil Liberties
- 8. The topics, number of presentations and number of attorneys who attended these seminars are presented in Appendix B. There has been a total of 18,245 registrations by attorneys for these seminars.

#### THE PROSPECTS OF A RETURN TO IN-PERSON SEMINARS

9. Jamaica is a low vaccination country with less than 5% of the population having received inoculation against Covid-19 and the uncertainties surrounding the availability of

supplies of vaccines in the foreseeable future. As a result, a return to in-person courses remains unpredictable. The general feedback is that attorneys enjoy being able to access courses on demand. We will continue to evaluate methods of delivery and to assimilate technology into the delivery of seminars.

#### FINANCIAL CONSIDERATIONS

- 10. Despite the challenges, in the relevant period the CLPD Committee continued to generate revenue far in excess of its expenditure. Over this period the net contribution of the Committee to the Council's coffers was approximately J\$31.3 million. A financial report showing the income and expenditure of the Committee over the period March 2013 to March 2021 is attached as Appendix C.
- 11. The relatively low cost of delivering 62 seminars over the relevant period is accounted for by the following:
  - The comparatively low cost of delivering webinars using zoom
  - Members of the CLPD Committee donate their time to the Council in planning a schedule of seminars for the year
  - Members of the CLPD Committee assist in the selection of topics and presenters
  - Members of the CLPD Committee prepare and present papers
  - Members of the CLPD Committee donate their time to review papers to ensure that they meet the required standards
  - Presenters donate their time without a fee in the research, preparation, and presentation of the seminar papers
  - Staff at the Council undertake the responsibility of advertising the seminars through email and other economical means
- 12. The major costs associated with the programme has been incurred for the rental of venues, provision of refreshments, accommodation of presenters and staff members for seminars held out of town, and administrative costs. Most of these costs were significantly reduced by reason of the transition to on-line presentations using technology.
- 13. It should also be observed that the number of registrants for seminars increased significantly over the previous period. This accounts for the improvement in the net contribution to the coffers of the Council. This is undoubtedly, the result of the hard work of the members of staff, the Committee and the presenters who volunteered their time to research, prepare and present papers which attracted widespread interest.

14. Nevertheless, the Committee is cautious in its expectation for the sustainability of this high level of income. In order to continue to attract the support of the profession, the CLPD Committee must produce seminars which engage the interests of the attorneys while adding value to their practice.

#### *Utilisation of Electronic Technology:*

- 15. On March 10, 2019 the CLPD Committee facilitated its first seminar using an online platform. Since then, the facility became more critical because of the measures put in place by the Government of Jamaica to limit the spread of Covid-19. Courses are now offered exclusively online. In addition to the question and answer and chat features in the webinar, attorneys are invited to submit questions and feedback using email. The Committee continues to explore the use of technology to engage the interest and participation of attorneys.
- 16. As part of its mandate to increase efficiency in communication, the Committee has implemented electronic processing of Certificates of Participation which are sent via email and are automatically generated through the GLC's database. Soft copies of seminar papers are also distributed by email to the attendees.

#### THE WAY FORWARD

17. The CLPD Committee is fortunate to have benefited from the wealth of experience of members of the profession who graciously lend their time and effort to the preparation and delivery of interesting seminars. The Committee is keen to nurture young talented attorneys to use their voices to effect change and has been pleased to give a platform to young counsel who wish to speak on issues of law which resonate with them. It is also important to continue evaluating the methods of delivery and the use of technology to deliver seminars. The Committee aims to ensure that the process is seamless from registration to evaluation.

#### CONCLUSION

- 18. The Committee is immensely grateful to those attorneys who have voluntarily prepared and presented papers during the year under review as well as those who have undertaken to make further presentations.
- 19. The Committee continues to express its gratitude to the GLC's administrative staff who have assisted with the successful delivery of the CLPD programme over the year under review.

- 20. The Committee is particularly grateful to Miss Tanya Ferril, the CLPD Coordinator, Mr. Ackeem Anglin, the Information System Coordinator and Mr. Ian Jackson, the GLC's CEO, who provided crucial support over the entire period.
- 21. As the Committee looks ahead it will need to consider the expansion and diversification of subject areas to maintain attorneys' interest and encourage greater participation. This will also involve exploring the need to engage experts from related disciplines and the question of the costs which may be associated with the engagement of such persons.

We have conducted at times hearings in person ensuring at all times that the Covid protocols established were followed. We hope to be able to shortly resume physical hearings.
