# GENERAL LEGAL COUNCIL ANNUAL REPORT

# **APRIL 1, 2012 – MARCH 31, 2013**

#### INTRODUCTION

The General Legal Council was established in January 1972 by the Legal Profession Act. Its statutory function is concerned with the legal profession and in particular the organization of legal education and the upholding of standards of professional conduct. By virtue of the Legal Education Act, the General Legal Council's function as the Legal Education Authority is vested in the Council of Legal Education which is established by Agreement among several Commonwealth Caribbean countries.

Apart from Law Officers of the Crown and legal officers of Government who are *ex officio* entitled to practise as such, no person can lawfully practise as an attorney who does not hold a practising certificate issued by the General Legal Council. Practising Certificates are issued annually on payment of an annual fee.

The General Legal Council is required to appoint from among its members or former members, Judges or retired Judges and attorneys of not less than ten (10) years standing to the Disciplinary Committee which adjudicates on complaints of misconduct by attorneys in any professional respect.

The General Legal Council is authorized to make rules prescribing the standards of professional etiquette and professional conduct for attorneys and to direct that any specified breaches of such rules constitute misconduct in a professional respect.

# 3. MANAGEMENT COUNSULTANT

The Council has undertaken a restructuring of its operations based on the report which was received from PricewaterhouseCoopers for a more efficient performance of its functions.

#### 4. SALARIES

In 2012, the Council approved a 12% increase in salaries and increased the base figure of the allowance paid to members of staff for work done on Saturdays to \$3,000.00.

#### 5. GENERAL LEGAL COUNCIL'S STAFF TRAINING

The staff was trained in the use of the following Microsoft applications: MS Word 2007, MS Excel 2007, MS Outlook 2007 and MS PowerPoint 2007.

# 6. <u>SECURITY AT GENERAL LEGAL COUNCIL OFFICES</u>

Consequent on an incident of theft which occurred in November 2012, the Council contracted with Quest Security Services Ltd. for the service of an unarmed guard at its offices.

#### 7. DEBIT/CREDIT CARD PAYMENT SYSTEM

A card payment system has been implemented to facilitate the payment of practising certificate and CLPD seminars fees by attorneys-at-law. It was agreed that the Council would defray the associated costs at this time.

#### 8. APPEALS FROM DECISIONS OF THE DISCIPLINARY COMMITTEE

Appeals have been filed by Eileen Crosbie Salmon, Oswald James, Ernest Davis, Joseph Allen and Sheldon Codner against disciplinary decisions made against them. Fifteen appeals are pending to date.

#### 9. OTHER COMMITTEES

In addition to the Disciplinary Committee (which was created by the Act) the Council has established the following committees to assist in carrying out its functions. ## 10. CONTINUING LEGAL PROFESSIONAL DEVELOPMENT (CLPD)

The Legal Profession (Continuing Legal Professional Development) Regulations, 2013 were enacted on January 29, 2013. The Council established a CLPD department in January 2013 and employed Ms. Venessa McLean on January 7, 2013 as its Director.

The CLPD Committee (chaired by Dr Lloyd Barnett) has summarized in lay terms what is required of attorneys and this has been published on the Council's website and communicated by email to all practising attorneys.

In February 2013, the Council started a series of CLPD seminars. Four seminars were held in Kingston. These seminars were attended by 1,100 attorneys. The seminars continued in March, when one was held in Kingston, two were held in Mandeville; one in Ocho Rios and two in Montego Bay. A total of 400 persons

attended the seminars in March. The schedule of seminars was published on the Council's website and in the newspapers.

# 11. ACCREDITATION COMMITTEE

The Continuing Legal Professional Development Accreditation Committee is a statutory body which came into effect February 1, 2013. It devises the criteria and requirements for the accreditation of courses and other activities; accredits courses and other activities comprising a CLPD programme and assesses the hours to be credited for participation in any CLPD programme.

Mrs. Donna Scott-Mottley was appointed as chairman of this Committee.

As at March 31, 2013, one application for accreditation has been approved and two applications refused

#### 12. REFORM OF THE LEGAL PROFESSION ACT

There were a number of changes re the persons holding the positions of Minister of Justice and Attorney General during the year under review. Council met with and briefed each incoming Minister/AG in relation to the Bill to amend the Legal Profession Act. There were also continued consultation with and representations by the Bar.

The amending act was finally enacted and brought into force in December 2012. In addition to establishing a requirement that all practising attorneys take part in CLPD, the amendments also empower the Council to take action to protect clients' files and assets in specified cases. Those include cases where an attorney has died, been struck off the roll or has left the country without making adequate arrangements to protect their clients' files or property.

The amendments also establish a compensation fund and authorize the Council to regulate and administer it. The Council has started preparations for this task.

# 13. PROCEEDS OF CRIME ACT

The draft cabinet submission indicated that the Council's recommendations have been adopted that the Council should be the competent authority to regulate the profession and that the profession should be regulated separately from other sectors.

The General Legal Council has been actively engaged in the past year in considering the regulatory regime which will be created to regulate attorneys under the Proceeds of Crime Act. The General Legal Council created a subcommittee of persons with expertise in this field to make recommendations in that regard and these recommendations were considered and approved by Council in May 2012 and forwarded to the relevant Government agency having responsibility for carriage of the matter.

In the reporting period, representative of the Council also met with the CFATF Mission Team on 11<sup>th</sup> September, 2012, who indicated approval of the Council's policy and particularly agreed that to be effective, the regulatory regime will need to be enforced by a mix of disciplinary/administrative sanctions as the experience of other jurisdictions has taught that reliance on criminal sanctions will simply clog the criminal justice system and prove ineffective in the long term.

Representatives of the Council also met with the responsible Ministers and their team on 22<sup>nd</sup> October 2012 and thereafter moved apace in giving its comments on the Draft Cabinet Submissions and the Draft Bill to amend the relevant legislation.

The Council is on target to have its regulatory regime implemented by the Government's target date.

#### 14. INFORMATION TECHNOLOGY

The Information Technology Committee continues on its exercise to rationalize the Council's database of attorneys to obtain current and accurate information in relation to practising attorneys. It is intended that the revised data will be accessible on the website as upgrade of the website continues.

## 15. ACTION TO PROTECT CLIENTS' PROPERTY

This Committee is investigating the cases of two attorneys' offices in Montego Bay which have been locked up with clients' files.

#### 16. <u>LEGAL AID COUNCIL</u>

Mrs. Michelle Champagnie was appointed to represent the Council.

## 17. ACCOUNTING REPORTS

For the year under review, 1,130 attorneys filed either the First Schedule or the Second Schedule under the Legal Profession (Accounts & Records) Regulations, 1999 as follows:

- 433 attorneys filed the First Schedule;
- 697 filed the Second Schedule.

It was noted that some attorneys have filed the First Schedule indicating that they do not hold clients' funds when there are in fact indications that they do.

#### 18. ACCOUNTS OF THE GENERAL LEGAL COUNCIL

The Council's accounts have now been audited up to the financial year 2012 - 2013.

#### 19. PRACTISING CERTIFICATE FEES

It is estimated that there are more than 3,000 attorneys on the roll. In 2012/2013 1,535 attorneys held practising certificates. The Council has published on its website and in the newspaper, a list of attorneys who are entitled to practise by virtue of their having paid their practising certificate fees. The Council is also working with the Chief Justice, the Registrar of Titles and other relevant departments to ensure that persons who are not entitled to practice are not allowed to do so.

## 25. SEMINARS

One seminar was held during the year under review, on January 28, 2013.

#### 26. ORDERS MADE AGAINST ATTORNEYS

Chrystine Bernard was found guilty of professional misconduct for her failure to account to the Complainant for money she received from him with regard to the purchase of a property for the complainant. The attorney has failed to account to the Complainant for the amount of \$913, 807.50 paid to her by the complainant as the relevant deposit, for the necessary stamping as well as on account of legal fees. The attorney did not stamp the agreement or register the transfer on the title nor take any adequate steps to see to the completion of the transaction. The Attorney was **struck from the Roll** of Attorneys-at-law entitled to practise in Jamaica. She was ordered to pay to the Complainant by way of

restitution the amount of \$1,182,761.40 being \$913,807.50 with interest thereon at the rate of 10% per annum from the 10th March, 2010 to 11th March, 2012) the attorney was further ordered to pay costs to the General Legal Council in the sum of \$50,000.00, which amounts have not been paid. **The order was made on the 14th April, 2012.** 

Lynden Wellesley was found guilty of professional misconduct for his conduct in the handling of a personal injury matter for the complainant. The Panel found that the attorney did not deal with his client's business with all due expedition and that the attorney has acted with inexcusable and deplorable negligence or neglect in the performance of his duty to his client and that he has failed to provide the complainant with all information as to the progress of his business. The Panel ordered the attorney to pay a fine of \$2,000,000.00 to the General Legal Council of which \$500,000.00 is to be paid on or before the 1st July, 2012 and the balance of \$1,500,000.00 to be paid on or before 1st October, 2012. The Panel also directed that the fine be paid to the Complainant when collected by the General Legal Council in full satisfaction of any damages caused to him by the Respondent's misconduct. The attorney was also ordered to pay costs to the complainant in the sum of \$60,000.00 on or before the 1st July, 2012. The ordered was made on the 28th April, 2012. An amount of \$1,460,000.00 has been paid.

**Roger Davis** was found guilty of professional misconduct under section 12 (1) (a) of the Legal Profession (Accounts and Records) Regulations 1999 for his failure to deliver Accountant's Reports to the Secretary of the General Legal Council for the years 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009 contrary to section 16 (1) and 17 of the said Regulations. The attorney was ordered to pay a fine of \$15,000.00 for each year that he was found to be in breach of the Legal Profession (Accounts and Records) Regulations 1999 plus costs of \$15,000.00 to the General Legal Council. The costs and fine were ordered to be paid on or before the 15<sup>th</sup> July, 2012 but they have not been paid. **The order was made on the 19th May, 2012** 

Marie Chambers was found guilty of professional misconduct for her failure to have the Complainant's late husband's death noted on the title. The attorney was fined the sum of Two Hundred Thousand Dollars (\$200,000.00) to be paid to the complainant in partial satisfaction of any damages she may have suffered as a result of the Attorney's professional misconduct. The Attorney was also ordered to deliver all the documents including the Certificate of Title for the subject property forthwith. In the event the Attorney, Marie Chambers failed to do so, she would have been suspended from practice for a period of six (6) months

commencing on the 28th May, 2012. The Attorney was also ordered to pay costs of the proceedings in the amount of \$50,000.00 to the complainant, which has been paid. **The order was made on the 28th April, 2012** 

**Eileen Crosbie Salmon** was found guilty of professional misconduct contrary to section 12 (1) (a) of the Legal Profession (Accounts and Records) Regulations 1999 for her failure to deliver Accountant's reports to the Secretary of the General Legal Council for the years 2000 2001, 2003, 2004, contrary to section 16 (1) and 17 of the said Regulations. The attorney was ordered to pay a fine of \$5,000.00 for each year that she was found to be in breach of the said Regulations, a total of \$25,000.00, to be paid to the General Legal Council on or before the 25<sup>th</sup> May, 2012, which has not been paid. **The order was made on the 12th May, 2012. The Decision is being appealed.** 

Lonnette A. Fisher Lynch was found guilty of professional misconduct contrary to section 12 (1) (a) of the Legal Profession (Accounts and Records) Regulations 1999 for her failure to deliver Accountant's Reports to the Secretary of the General Legal Council for the years 2003, 2004, 2005, 2006, 2007, 2008, 2009 contrary to section 16 (1) and 17 of the said Regulations. The attorney was ordered to pay a fine of \$10,000.00 for each year that she was found to be in breach of the Legal Profession (Accounts and Records) Regulations 1999 plus costs of \$10,000.00 to the General Legal Council making a total cost of \$80,000.00 to be paid on or before 30th April, 2012, which has been paid. The order was made on the 25th February, 2013

**Arthur Kitchin** was found guilty of professional misconduct for his failure to complete a real estate transaction on behalf of the Complainant. The attorney was **struck from the Roll** of attorneys-at-law entitled to practise in Jamaica. The attorney was also ordered to pay by way of restitution to the complainant the sum of \$601,500.22 being the balance due to the complainant plus accrued interest of \$141,020.42. The attorney was also ordered to pay interest at the rate of 6% per annum on the said sum of \$601,500.22 from the date ordered until the date of payment. The amounts have not been paid. **The order was made on the 23rd June, 2012** 

**Judith Pantry** was found guilty of professional misconduct contrary to section 12 (1) (a) of the Legal Profession (Accounts and Records) Regulations 1999 for her failure to deliver Accountant's Reports to the Secretary of the General Legal Council for the years 2002, 2003, 2004, and 2005, contrary to section 16 (1) and 17 of the said Regulations. The attorney was ordered to pay a fine of \$15,000.00

for each year that he was found to be in breach of the Legal Profession (Accounts and Records) Regulations 1999 plus costs of \$15,000.00 to the General Legal Council. The costs and fine were ordered to be paid on or before the 7th August, 2012 and have not been paid. **The Order was made on 21st. July, 2012** 

**Oswald James** was found guilty of professional misconduct for his failure to account to the complainant for the sum of US\$337,500.00 which was sent to the Attorney by the complainant for the acquisition of a property. The complainant asked for the return of the money and the attorney was unable to refund same. The attorney wrote a letter to the complainant undertaking to refund the balance of money on or before the 30th July, 2008. The attorney failed to honour the undertaking. The attorney repaid only US\$100,000.00 of the US\$337,500.00 held to the complainant's account.

The attorney was **struck from the Roll** of Attorneys entitled to practise in the several Courts of Jamaica. The attorney was ordered to grant restitution to the Complainant in the sum of US\$237,500.00 with interest there on at the rate of 3% per annum from the 15th April, 2008 until payment. The attorney was ordered to pay cost to the complainant in the sum of \$100,000.00. The amounts have not been paid. **The order was made on the 11th September, 2012. This matter is being appealed.** 

**Ernest Davis** was found guilty of professional misconduct for his failure to investigate the Will of Iris Berry and Protect the interest of Israel Berry's in the property at Norwich and to get information of the deceased's bank account. The attorney was fined the sum of \$150,000.00 to be paid within 45 days of the 28th April, 2012. The fine was to be paid to the complainant in satisfaction of any damages that she may have suffered as a result of the Attorney's misconduct. The attorney was also ordered to pay for costs of the proceedings in the amount of \$20,000.00. The fine and costs have not been paid. **The order was made on the 28th April, 2012. This matter is being appealed.** 

**Rosalea P. Hamilton** was found guilty of professional misconduct contrary to section 12 (1) (a) of the Legal Profession (Accounts and Records) Regulations 1999 for her failure to deliver Accountant's Reports to the Secretary of the General Legal Council for the years 1999, 2000, 2001, 2002, and 2002, 2003, 2004, 2004, 2006, 2007, 2008 and 2009 contrary to section 16 (1) and 17 of the said Regulations. The attorney was ordered to pay a fine of \$10,000.00 for each year that she was found to be in breach of said Regulations; to be paid on or

before the 25th October, 2012, which has been paid. The order was made on the 6th October, 2012.

Antoinette Haughton-Cardenas was found guilty of professional misconduct for her failure to prosecute a fatal accident claim on behalf of the Complainant. The Attorney was retained in September, 1993 and was provided with the necessary information pertaining to the identity of the owners and driver of the vehicle. The attorney commenced action correctly naming the driver but incorrectly naming the owner. The attorney failed to commence action against the owner and the driver of the other vehicles involved in the accident. The attorney was fined a sum of \$500,000.00 and directed that the entire fine be applied towards compensation of the Complainant in her capacity as representative of the estate of Robert White (deceased). The attorney was ordered to pay a fine of \$50,000.00 the General Legal Council. The fines have not been paid. The order was made on the 8th December, 2012.

Ethlyn Norton Coke was found guilty of professional misconduct for her failure to complete and transfer the correct title to the complainant. The attorney was ordered to pay a fine to the Complainant in the sum of \$100,000.00 to enable another attorney to complete the matter, if she had not completed the transfer of the correct title to the complainant by the date of the order. In addition, the attorney was ordered to pay costs previously ordered in this matter amounting to (i) £240.00 plus J\$350.00 1st March 1997. (see condition at paragraph 2 of the judgment), ii)\$37,000 (J) -20th November, 2000; iii) \$1,000 .00 (J)- 30th September, 2000.; iv) 5th June 2010 less any amount that she has paid already. The amounts have not been paid. The order was made on the 29th January, 2013

**Sheldon Codner** was found guilty of professional misconduct for his failure to complete a transaction on behalf of the complainants in a sales transaction of land. The purchase price for the land was \$27,000,000.00 and the complainants in pursuance of the Agreement for Sale paid over a total sum of \$25,197,000.00 to the attorney and the attorney admitted receiving all these sums from the complainants. The attorney paid over the sums of \$4,050,000.00 and \$47,000.00 to Samuda and Johnson.

The attorney did not pay over the sums of \$18,500,000.00 and \$62,600,000.00 to Samuda & Johnson although he was obliged in law to do so, nor did he refund the amounts of \$18,500,000.00 and \$2,600,000.00 to the Complainants when they demanded that he do so. The Panel ordered that the name of the Attorney

Sheldon Codner be struck from the Roll of Attorneys-at-law entitled to practise in Jamaica and that the Attorney should make immediate restitution of the sum of \$12,100,000.00 to the Complainant with interest at the rate of 6% per annum for the 20th April, 2011 until payment. The attorney was also ordered to pay interest at the rate of 6% per annum on the sum of \$9,000,000.00 from the 20th April 2011 until 31 July, 2011. The Attorney was ordered to pay costs of \$50,000.00 to the General Legal Council. The amounts have not been paid. The order was made on the 19th May, 2012. A rehearing of this complaint has been requested by the attorney.

Conrad Powell was found guilty of professional misconduct for his failure to account to the Complainant for all monies entrusted to him on behalf of the complainant in the amount of \$11,433,622.00 in which he acted for both the vendor and purchaser in the sale of a property. The Complainant is in possession of the property the subject of the sale. The Attorney gave an unsigned Agreement for Sale to the Complainant which agreement was not executed either by the Vendor or the Purchaser. There is no evidence that Instrument of Transfer was prepared by the Attorney and there is no evidence that the Complainant's name has been endorsed on the Certificate of Title and the attorney has not refunded any of the sums paid to him by the Complainant. The Attorney was ordered to pay a fine of \$500,000.00 to the General Legal Council plus costs of \$30,000.00 to the Complainant, which have not been paid. The Order was made on the 29th May, 2012

**Sean Kinghorn** was found guilty of professional misconduct for his failure to bring action on behalf of the complainant arising out of injuries he suffered in a motor vehicle accident. The complainant provided the attorney with medical report and a police report which contained particulars of the intended Defendants. The attorney did file a Claim on the 29th January. 2004 which was served on the Defendant with the aid of the Police. The Complainant unsuccessfully attempted to get information from his attorney as to the progress In 2008 the attorney told him he was unable to locate the of his case. Defendants for service. The complainant retrieved his papers from the attorney in 2008. The attorney was ordered to pay a fine of \$600,000.00; \$500,000.00 of which was to be paid to the Complainant in part satisfaction of any damages caused pursuant to Section 12(5) of the Legal Profession Act. The attorney was also ordered to pay costs to the Complainant in the amount of \$6,000.00. These amounts have not been paid.

The panel also reminded the attorney that the Legal Profession (Canons of Professional Ethics) Amendment Rules (1983) requires a response to all complaints and the attendance of the Attorney at the Disciplinary hearings. The Attorney was cautioned that failure to abide by this Canon could be the subject of a separate complaint. However, this section of the Canon was not taken into consideration in giving judgment in the matter. **The order was made on the 12th January, 2013** 

**Keisha McDonald** was found guilty of professional misconduct for her failure to account accurately to her clients for moneys held by her on their behalf and she has misled her clients as to the status of their transaction. Miss McDonald acted as the Vendors' attorney in the sale of a property Townhouse # 15 Waterloo Road, Kingston 10, having title registered at Volume 1127 Folio 104. Miss McDonald was ordered to pay a fine of Eighty Thousand Dollars (\$80,000.00) plus a sum of Three Hundred and Forty Two Thousand Dollars (\$342,000.00) to the complainants by way of restitution, which amounts have not been paid. **The Order was made on the 23rd March, 2013** 

Norman Manley was found guilty of professional misconduct for his failure to pursue a case of unlawful shooting that had occurred on the 6th September, 2007 to the Complainant when the Police entered his house and shot him. The Complainant paid a retainer of US\$400.00 to the Attorney as evidenced by his receipt dated 7th September, 2007. Notwithstanding that the Complainant had identified the police officer responsible for entering his house and shooting him the attorney failed to pursue the filing of a case. By letter dated 2st December, 2009 the Complainant wrote the General Legal Council complaining about the conduct of the Attorney. Consequently the attorney refunded the retainer fee by payment of J\$35,000.00 on June 11, 2010. The attorney has given no explanation for withdrawing and terminating the retainer. The panel found that the attorney was in breach of the Canon IV (r) of the Legal Profession Canon of Professional Ethics Rules and further that he attorney acted with inexcusable and deplorable neglect in the performance of his duties to the complainant and ordered that the Attorney Norman Manley be reprimanded and that the Attorney pays costs to the complainant inclusive of previous costs ordered in the sum of \$40,000.00, which has not been paid. The order was made on the 29th January, 2013

**Arthur Kitchin** was found guilty of professional misconduct for his failure to pursue a criminal appeal for the Complainant's brother. The Complainant paid the Attorney \$165,932.00. Mr. Kitchin did not pursue the appeal and promised to

refund the money. The attorney has failed to do so. The attorney was struck from the Roll in an unrelated matter. The Attorney was ordered to pay to the Complainant the sum of \$165,932.00 together with interest thereon at the rate of 6% per annum from 30th May, 2011 to the date of payment, which has not yet been paid **The order was made on the 29th January, 2013.** 

**Ronald Boswick** was found guilty of professional misconduct contrary to section 12 (1) (a) of the Legal Profession (Accounts and Records) Regulations 1999 for his failure to deliver Accountant's Reports to the Secretary of the General Legal Council for the years 2002, 2002, 2003, and 2004, contrary to section 16 (1) and 17 of the said Regulations. The attorney was ordered to pay a fine of \$15,000.00 for each year that he was found to be in breach of the said Regulations plus costs of \$15,000.00 to the General Legal Council. The costs and fine which were ordered to be paid on or before the 28th February, 2013 have not yet been paid. **The order was made on the 26th January, 2013**

## **CONCLUSION**

The General Legal Council faces various challenges. These include ensuring greater compliance with the Act and the Regulations, including the requirements that attorneys file annual accounting reports and hold current practising certificates. The Council is also seeking to improve the efficiency of its operations, and in particular, to expedite the processes of dealing with complaints.

2013-2014 will be the first full year of the application of the amendments to the Legal Profession Act which authorized the Council to take action to protect clients' files and property, established a compensation fund and provided for mandatory continuing legal professional development. There will also be another significant increase in the number of new attorneys. The Council is preparing to deal with these additional responsibilities, and may make further representations to the Ministry and Parliament for changes to the legislation.
