INTRODUCTION

The General Legal Council was established in January 1972 by the Legal Profession Act. Its statutory function is concerned with the legal profession and in particular the organization of legal education and the upholding of standards of professional conduct. By virtue of the Legal Education Act, the Council's function as the Legal Education Authority is vested in the Council of Legal Education which is established by Agreement among several Commonwealth Caribbean countries.

Apart from Law Officers of the Crown and legal officers of Government who are *ex officio* entitled to practise as such, no person can lawfully practise as an attorney who does not hold a practising certificate issued by the Council. Practising Certificates are issued annually on satisfying certain requirements, including the payment of an annual fee.

The Council is required to appoint from among its members or former members, Judges or retired Judges and attorneys of not less than ten (10) years standing, the Disciplinary Committee which adjudicates on complaints of misconduct by attorneys in any professional respect.

The Council is authorized to make rules prescribing the standards of professional etiquette and professional conduct for attorneys and to direct that any specified breaches of such rules constitute misconduct in a professional respect.

CHAIRMAN'S MESSAGE:

A new Council was appointed with effect 25th April 2019 for a term of 3 years. Seven members were appointed to the Council for the first time while an eighth member had held previous appointment. Special thanks is extended to the outgoing Members of the Council.

The outgoing Members of Council can rightly look back with satisfaction at what has been achieved. Perhaps the signal achievement has been the enactment of the Legal Profession (Contingency Fees) Regulations 2018 in compliance with the mandate given to Council by the amendment to the Legal Profession Act promulgated in 2007. The Contingency Fee Regulations came into effect on 1st February 2019 to prescribe measures regulating the form and content of contingency fee agreements and prescribing limits on the percentages that can be charged in legal proceedings, including personal injury actions and family law proceedings. Restriction is also imposed on taking contingency fees from damages awarded for future medical care.

The Legal Profession (Accounts and Records) Amendment Regulations 2018 and 2019 accompanied by the Guidelines on the With-Holding of Practising Certificates for Non-Compliance were also enacted. The objective of these measures is to close loopholes with regards to the filing of accountant's reports and to withhold practising certificates from attorneys who have been non-compliant for multiple years thereby reducing the necessity for the filing of complaints with the Disciplinary Committee against such attorneys.

The General Legal Council has been compelled to intervene in protection of client property in a number of instances where attorneys have died without arrangements in place for the handing over of client property. This has resulted in considerable strain on the limited resources of Council. However, Council has successfully intervened and where necessary obtained orders from the Supreme Court so to do. The Legal Profession (Canons of Professional Ethics) Amendment Rules 2019 now require sole practitioners to put in place arrangements to protect client property in event of death or incapacity and also requiring that Council be notified of such arrangements.

In 2018 case management software similar to that utilized by the Caribbean Court of Justice was acquired for the Disciplinary Committee. The adoption of the case management system coupled

with training and the dedicated work of the members and staff of the Disciplinary Committee has met with phenomenal results whereby the Disciplinary Committee has more than tripled the number of complaints concluded in this year as compared to the preceding year. This has virtually cleared the backlog of complaints.

The Continuing Legal Professional Development Program (CLPD) continues to be a success and a webinar system has been implemented whereby attorneys who are unable to attend seminars can now participate. This is intended to facilitate attorneys who require CLPD credits but are unable to attend sessions whether by reason of being overseas or otherwise. This should greatly alleviate the difficulty that such attorneys have experienced in obtaining their CLPD credits.

In addition, the The Legal Profession (Continuing Legal Professional Development) (Amendment) Regulations 2018 empowers the Accreditation Committee to accredit established providers such as the Jamaican Bar Association. No longer will such providers have to obtain accreditation of their programs from the GLC's Accreditation Committee. This measure will alleviate the difficulties experienced in preceding years where the Accreditation Committee has had a backlog of programs awaiting accreditation to the inconvenience of participating attorneys.

The new Council will pursue its mandate to regulate the Legal Profession in the public interest. I extend thanks and appreciation to all Members of Council, the Disciplinary Committee and the Council's dedicated staff who continue to serve loyally and well.

3. STAFF

The card payment system which was implemented to facilitate the payment of practising certificate and CLPD seminar fees by attorneys-at-law has been well utilized and the Council has been moving towards a completely cashless system for security related reasons.

7. ACCREDITATION COMMITTEE

- 1. During the period, January December 2018, the Committee received a total of 442 new applications from institutions for accreditation of courses to be presented by them and 5 applications for renewal of accreditation. There were 345 applications for exemptions and 209 applications from individuals for credits for activities in which they had participated. Of the total of 996 applications which were reviewed during the period, 857 applications were successfully addressed, 2 were refused, and 137 were deferred.
- 2. The data also discloses that during that period, of a total number of 2018 attorneys, 558 are fully compliant in their participation in CLPD programmes and 1293 are partially compliant, as is indicated on the compliance schedule attached. Attorneys have until November 2019 to become fully compliant. 63 attorneys have received exemptions; 69 received extensions and 3 are within their extended period for compliance.
- 3. The Accreditation Committee is pleased to report that consequent on the promulgation of the *Legal Profession (Continuing Legal Professional Development) (Amendment)**Regulations, 2018, in March 2019, provider status has been conferred on the General Legal Council (to be effected through its Continuing Legal Professional Development Committee) and on the Jamaican Bar Association. This will undoubtedly result in a

significant reduction in the number of papers to be reviewed and processed by the Committee. However in accordance with the mandate imposed by the regulations, the Committee has implemented the requisite monitoring procedures and has required strict compliance with the same by the institutions on whom provider status has been conferred.

8. ADVERTISING REGULATORY COMMITTEE

During the period under review the Advertising Regulatory Committee of the General Legal Council ("the Committee") met nine (9) times.

During the period, the Committee:

- 1. Wrote eleven (11) letters to Attorneys-at-Law advising them that their websites, advertisements in the Yellow Pages and on the internet and social media platforms were in breach of the Canons of the Legal Profession (Canons of Professional Ethics) Rules ("the Canons"). The nature of the breaches ranged from advertising summer specials at reduced rates; sole practitioners practicing using the business name "& Co."; Attorneys claiming to be specialists and implying superiority over other Attorneys. Five (5) Attorneys responded favourably to our letters agreeing to remove the advertisements and thanking the Committee for its guidance.
- 2. Communicated with the General Legal Council on certain Attorneys who have refused to comply with our letters advising them of breaches of the Canons and asking them to desist in the future. Of particular note was the law firm Bignall Law who circulated an advertisement over the Christmas season, December, 2018, which was also in breach of an Order made by the General Legal Council on the 26th September, 2018 in that the law firm

failed to first get the approval of the General Legal Council before releasing the advertisement. A recommendation was made to the General Legal Council to lay a complaint.

3. Updated the advertising guidelines which were posted on the General Legal Council's website.

9. <u>CONTINUING LEGAL PROFESSIONAL DEVELOPMENT (CLPD)</u>

INTRODUCTION

1. The CLPD Committee of the General Legal Council was established in 2013 and since May 2015 has been chaired by the Hon. Mr. Justice C. Dennis Morrison. The Committee aims to meet at least once per month during term time and has from time to time met more frequently as the need has arisen. The full membership of the Committee is shown in Appendix A.

FUNCTIONS

- 2. The scope of the Committee's work is:
 - To design and present courses for the purpose of the continuing legal professional development of attorneys-at-law;
 - ii) To arrange programmes for the delivery of CLPD seminars on an island wide basis; and
 - iii) To ensure that there are adequate offerings in Ethics and Client Welfare,
 Business Management and Finance.
- 3. In January 2019 the General Legal Council was granted accredited provider status. Consequently the Committee assumed the additional responsibility of awarding credits to the courses it presents, subject to the approval of the Accreditation Committee.
- 4. In carrying out its functions, the CLPD Committee encourages the conduct of research in the preparation of papers on a variety of legal subjects. In the relevant period, the Committee presented papers on topics such as: arbitration, mediation, advocacy, administrative law, corporate and commercial law, conveyancing, criminal law, taxation,

intellectual property, sports law, law and technology, banking law, Caricom law and employment law, among others. Regarding the mandatory requirements for presentations in Ethics and Client Welfare, Business Management and Finance, the Committee has also sought to ensure that there have been adequate offerings in these subjects.

- 5. In fulfilling its mandate to ensure that seminars are accessible island wide, the Committee holds seminars in Kingston, Mandeville in Manchester, Montego Bay in St. James, Ocho Rios in St. Ann.
- 6. A total of 82 seminars were held during the period April 1, 2018 March 31, 2019, broken down as follows:
 - Mandeville (3);
 - St. Ann (10),
 - St. James (10); and
 - Kingston and St. Andrew (59);
- 7. Of the Fifty-Nine (59) seminars held in Kingston, Thirty-Two (32) were held in collaboration with the CCJ Academy of Law Conference, which is reported below.
- 8. The topics, number of presentations and number of attorneys who attended these seminars are presented in Appendix B. There has been a total of 10,612 registrations by attorneys for these seminars.
- 9. It should be noted that the CLPD Committee has responded to the requests of Seventh Day Adventists and has as far as practicable, tried to accommodate more seminars on Sundays.

REGIONAL SEMINARS

10. A regional seminar refers to a cluster of seminars held over a 1-2 day period. The aim of holding regional seminars is:

- To provide accessible CLPD opportunities for attorneys who reside or practice in different areas of Jamaica;
- To provide attorneys with the opportunity to complete as many of their CLPD credits as possible during a single weekend;
- To present specific legal topics that may be associated with particular regions;
- To reduce administrative expenses; and
- To facilitate the attorneys' compliance with their CLPD obligations.
- 11. Regional seminars were held in the relevant period in the following locations:
 - i) May 26 -27, 2018, Kingston
 - ii) October 6-7, 2018, Ocho Rios, St. Ann
 - iii) March 9-10, 2019, Montego Bay, St. James

5th Biennial Conference on Law "The Future of Legal Practice in the Caribbean – Catalyst for Regional Success?

- 12. In December 2018, the General Legal Council collaborated with the CCJ Academy for Law to stage the 5th Biennial Conference on Law, under the theme "The Future of Legal Practice in the Caribbean Catalyst for Regional Success?"
- 13. The Conference was held in Jamaica over the period December 13-15, 2018 and attracted attendees from outside of Jamaica as well as local attorneys. This conference marked the second time the General Legal Council and the CCJ Academy for Law joined forces to plan a conference. The partnership with the CCJ deepened the pool of talent from which a diverse array of presenters and presentations were drawn.
- 14. The topics, number of presentations and number of attorneys who attended these seminars are presented in Appendix C. The costs were shared between the CCJ Academy for Law and the General Legal Council. The net financial contribution to the General Legal Council was J\$2,271,625.00.

FINANCIAL CONSIDERATIONS

- 15. The CLPD Committee continues to generate revenue far in excess of its expenditure. Over the relevant period, the net contribution of the Committee to the Council's coffers was therefore approximately J\$19.43 million. A financial report showing the income and expenditure of the Committee over the period April 2013 to March 2019 is attached as Appendix D.
- 16. The following factors contributed to the relatively low cost of delivering 82 seminars over the relevant period is accounted for by the following:
 - Members of the CLPD Committee donated their time to the Council in planning a schedule of seminars for the year;
 - Members of the CLPD Committee assisted in the selection of topics and presenters;
 - Members of the CLPD Committee prepared and presented papers;
 - Members of the CLPD Committee donated their time to review papers, to ensure that they met the required standards;
 - Presenters donated their time without a fee, in the research, preparation and presentation of the seminar papers;
 - Staff at the Council undertook the responsibility of advertising the seminars through email and other media; and
 - The majority of the seminars take place at the Lloyd Barnett Seminar Rooms, formerly Jambar Conference Hall, which has been leased on a long-term basis by the GLC.
- 17. The major costs associated with the programme relate to the rental of venues, provision of refreshments, accommodation of presenters and staff members for seminars held out of town, and the photocopying of seminar papers.
- 18. Notwithstanding the quite favourable income to expenditure ratio, the Committee continues to explore possible cost containment measures which target the only expenses associated with the programme. These include:

- i) Identifying less costly alternative venues;
- ii) Designing seminars to attract both legal and non-legal attendees, e.g.; accounting professionals, real estate practitioners etc.;
- iii) Reducing the assortment of refreshments;
- iv) Rationalising the selection of venues outside of Kingston and/or arranging them in clusters; and
- v) Sending seminar papers to participants electronically.

Nevertheless, the Committee has striven to avoid reducing standards for the hosting of the seminars so as not to endanger the quality of the product.

19. The year under review showed marked improvement in the financial returns. There was an increase in the income, number of seminars and attorneys attending seminars. These achievements have been gained despite increasing competition. The net contribution of the programme to the General Legal Council was the highest since the programme started. This is undoubtedly, the result of the hard work of the members of staff, the Committee and the presenters who volunteered their time to research, prepare and present papers.

FUTURE DEVELOPMENTS

Utilisation of Electronic Technology:

20. On March 10, 2019, seven (7) attorneys participated in three seminars using the webinar service. The attorneys were able to ask questions of the presenter and gave positive feedback after the seminars by e-mail. All the attorneys who participated in the seminars were overseas. On March 30, 2019, fourteen (14) attorneys registered for the seminar

"Apparent Bias – the Judge is a Friend", presented by Mr. Allan Wood Q.C. through the

webinar service. Save for one attorney, these attorneys were in Jamaica. It is expected that

over time, the participation by webinar will increase. Seminars will continue to be offered

as webinars from time to time, as the programme continues.

21. As part of its mandate to increase efficiency in communication, the Committee has

implemented electronic processing of Certificates of Participation which are sent via email

and are automatically generated through the GLC's database. Soft copies of seminar papers

are also distributed by email to the attendees.

CONCLUSION

22. The Committee continues to express its gratitude to the GLC's administrative staff who

has assisted with the successful delivery of the CLPD programme over the year under

review.

23. The Committee is particularly grateful to Miss Tanya Ferril, the CLPD Coordinator and

Mr Ian Jackson, the GLC's CEO, who provided crucial support over the entire period.

24. As the Committee looks ahead, it will need to consider the expansion and diversification

of subject areas in order to maintain attorneys' interest and encourage greater participation.

This will also involve exploring the need to engage experts from related disciplines and the

question of the costs which may be associated with the engagement of such professionals.

10. <u>INFORMATION TECHNOLOGY COMMITTEE</u>

- During the year April 1, 2018 March 31, 2019, the General Legal Council continued to contract the services of Ms. Bertina Macaulay and Mr. Sean Williams to handle its Information Technology requirements.
- 2. Ms. Macaulay's responsibilities included the following software related issues:
 - i) maintenance of the Council's website;
 - ii) management of the database;
 - iii) management and maintenance of internet and email connectivity;
 - iv) providing statistical and analytical data;
 - v) securing licences for the operating systems;
 - vi) sourcing and installing software upgrades;
- 3. Mr. Williams' responsibilities covered hardware and networking matters:

- i) supply, installation and maintenance of servers, computers and other IT related equipment;
- ii) maintenance and upgrading of the internal IT network;
- iii) installation of anti-virus software
- iv) liaising with third-party providers e.g. FLOW, QUICKBOOKS etc.
- v) providing substantial IT support to resolve the multiplicity of accounting errors that were made during the year.
- 4. Beginning in April 2018, the General Legal Council implemented the following technological upgrades:
 - i) With the support and assistance of the Caribbean Court of Justice, the Disciplinary Committee began using the CURIA Court Management Software. Use of this software has significantly improved the Committee's administration, documentation and case management activities and has assisted to substantially reduce the backlog of outstanding disciplinary matters;
 - ii) The provision of laptop computers to all members of the Disciplinary Committee to receive verbatim notes of evidence for all Disciplinary Committee hearings has resulted in a marked improvement in the accuracy and delivery time of the notes of evidence and a marked reduction in paper consumption;
 - iii) By expanding the use of teleconferencing and video link facilities at sub-committee meetings and at Disciplinary Committee hearings, this has accommodated attorneys and complainants who are unable to personally attend either the meetings or hearings.
- 5. The Continuing Legal Education Committee of the GLC implemented an online platform in October 2018 which enables webinars to be streamed online, worldwide.
- i) The software used was supplied by Zoom Video Communications Inc;
- ii) There is a monthly charge from Zoom of US\$54.00 to facilitate 100 online participants at each presentation;
- iii) All seminars in Kingston will now be available online. However seminars presented in the rural parishes will, for the most part, not be available online due to insufficient telecommunications bandwidth at the locations;
- iv) Eight seminars have so far been streamed live with approximately 200 participants in total from the UK, USA, Canada, other Caribbean Islands and Hong Kong.

6. During the period under review, the Council's website received 182,357 visits from the territories listed below:

The Information Technology Committee has not met but interfaces with either the staff of the General Legal Council, or any of the IT Consultants as may be necessary, since issues which required intervention were satisfactorily addressed.

Although, the technological processes continue to function efficiently, it is anticipated that there will be the need for a review of the IT facilities as well as the content of the GLC website

in the upcoming year, to ensure maintenance of relevance and service to the profession and public alike.

11. PROTECTION OF CLIENTS' PROPERTY COMMITTEE

The following comprise the matters that have been addressed or are being addressed by the committee:

a. Estate Carol Vassell

No further former clients of Miss Vassall have come forward to retrieve their files or claim any of the funds being held by the GLC. An application has been made to the Supreme Court for directions, and specifically seeking the court's permission to pay the sums being held to the Accountant General and for the files currently being held by the GLC to be delivered to and stored at Government Archives. The application came on before the learned Master Harris on April 3, 2019. Miss Vassall's executor was present with an attorney at law, who indicated that they would not be opposing our application, save that they wished to include four (4) additional boxes of clients' files that they still had. The Judge adjourned the matter to May 30, 2019 at which time we expect to get the order as prayed.

In the interim, discussions will be had with the executor and/or her attorney to ensure that the files that are in their possession are properly indexed prior to transferring to the GLC.

b. Damion Masters

With Mr. Master's father's confirmation that he is in possession of the files of clients of Damion Masters, a further and final visit is to be made to determine whether his method of returning files to the former clients is sufficient. Mr. Jackson is to ascertain whether there is an inventory of the files and if not, one is to be established. However, since last year, the GLC has not received any queries by the former clients of Mr. Masters.

c. Cynthia Levy Brown and Estate Carlton Campbell

All advertisements for the former clients of both attorneys have not yielded any subsequent take up and the GLC has received no queries from any former client of either attorney. The Committee has therefore decided that it will seek to have the files currently being held by the GLC transferred to the Government archives for storage.

d. Henry Woodham St. John

There will be some follow up with the children of the deceased in an effort to ascertain whether satisfactory arrangement are in the place for dealing with his former client's property.

e. Lanza Turner-Bowen

The GLC made the decision to intervene on Mrs. Turner-Bowen's death mainly on the basis of the several queries that were received from her former clients. Her former landlord

facilitated the process of the removal of her files to the GLC and same will be examined with a view to indexing and reviewing in order to respond to the various queries that the GLC has received. The GLC has temporarily employed Miss Deanna McFarlane to assist in the processing of these files, and in particular to identify the files that have been the subject of queries, which at this time total about twelve (12).

In addition, Notices to several banks have been sent out, in particular Sagicor Bank, which we were informed held clients' funds for Mrs. Turner-Bowen. These notices requested that sums being held on behalf of clients be transferred to the GLC, pursuant to section 20D of the Legal Profession Act.

f. Attorneys removed from the Committee's consideration

Matters in relation to the following attorneys have been removed from the Committee's consideration:

(a) Mr. Richard Bonner – the Committee concluded that satisfactory arrangements were in place.

g. Other Matters

The Committee also noted the untimely passing of the following attorneys: Ms. Elham Bogle; Mr. Gareth Forbes; Mr. William Hines and Mrs. Eileen Crosbie-Salmon. With respect to Miss Bogle, we were advised that her mother had three (3) files for former clients, which were distributed to the respective clients. There has been one query received by the GLC and there will be some communication with her brother to assist. In so far as the other attorneys are concerned, the GLC has received no queries and at this time cannot say whether satisfactory arrangements have been made in relation to clients' property.

The proposed presentation in relation to the amendments to the Legal profession Act that impacts this sub-committee will to be done by Annaliesa Lindsay and Symone Mayhew sometime before the 2019 summer break.

12. ACCOUNTING REPORTS COMMITTEE

During the year under review the Committee did the following:

- a. Reviewed the Legal Profession (Accounts and Records) Regulations, 1999 amended on August 3, 2017 (the "Accounting Reports Regulations"), to correct errors and to update the form of Accountant's Report contained in the Second Schedule to the Accounting Reports Regulations. This further amendment was promulgated by the General Legal Council ("GLC") on April 2, 2019;
- b. Considered several policy issues raised by attorneys and reviewed the Accounting Reports Regulation in order to provide guidance to management regarding the interpretation of the Regulations or the policy of the GLC towards the issue raised;
- c. Reviewed and responded to requests for exemptions and extensions;
- d. Developed a policy to guide the implementation of the regulation for the withholding of practicing certificates for non-compliance with the Accounting Reports Regulations.
- e. Reviewed compliance with the Accounting Reports Regulations and recommended next steps, inclusive of the filing of complaints against non-compliant Attorneys;

During the period April 1, 2018 to March 31, 2019 there were 3734 attorneys on the roll and there were 2282 Practising Certificates issued.

Accountant Reports or Declarations are generally due by June 30 each year for the preceding calendar year (unless an attorney has a different 12 month period as his/her financial year). The average percentage compliance for the years 2000-2017 as at March 31, 2019 is 89.57%. As at March 31, 2019, compliance in respect of the year 2018 stood at 27.20% however, we continue to receive accountant reports and declarations in respect of this year, and anticipate the usual deluge of declarations and accounting reports by June 30, 2019, when most become due.

The 2017 amendment to the Accounting Reports Regulations empowered the GLC, where it was satisfied that the circumstances warranted it, to grant extensions of time to comply with the Accounting Reports Regulations. Additionally, the 2017 amendment also empowered the GLC to grant exemptions to attorneys who are exclusively employed outside Jamaica from the requirements under the Accounting Reports Regulations for the delivery of an accountant's report or declaration for the period of such employment outside Jamaica. During the period April 1, 2018 to March 31, 2019 there have been 4 applications for extensions which have been granted and 11 applications for exemptions which have been granted.

During the period April 1, 2018 to March 31, 2019 twelve (12) complaints were laid against attorneys who had failed to comply with the Accounting Reports Regulations.

13. FINANCE AND ACCOUNTING COMMTTEE

The Finance and Accounting Committee continued to guide, support and strengthen the Council's financial activities during the period April 1, 2018 – March 31, 2019.

The committee provided proper, adequate and rigorous supervision and direction, specifically in matters concerning expense containment and prudent investment opportunities.

Among the significant contributions made by the Committee during the period under review, was to assist the Chief Executive Officer to prepare the Council's annual revenue and expense budget.

The Finance and Accounts Committee also periodically monitored all financial inflows and outflows in accordance with the budgeted provisions, therefore ensuring that the Council's finances were carefully administered.

The Committee maintained a close working relationship with the external auditor to ensure that the Council's operational and reporting standards continued to be in line with the established accounting, financial and administrative procedures.

The members of the General Legal Council's Finance & Accounting Committee during the 2018/2019 financial year were, Messrs. Lowel Morgan (Chairman), Richard Ayoub, Stuart Stimpson, Stephen Shelton QC, and a Chartered Accountant, Ms. Paula Turner.

14. PRACTISING CERTIFICATE FEES

The following fee structure remained in effect:

Less than five years' standing - \$14,400.00

Five years' standing but less than fifteen - \$28,800.00

Fifteen years standing and over - \$43,200.00

Attorney-at-law who has retired from practice - \$10,000.00

Attorney-at-law in the first year of practice who

applies for a practising certificate after

September 1 in that year - \$7,200.00

It is estimated that there are Three Thousand, Seven Hundred Thirty-Four (3,734) attorneys on the roll. In 2018/2019 Two Thousand Two Hundred Eighty-Two (2,282) attorneys held practising

certificates. The Council has published on its website, a list of attorneys who are entitled to practise by virtue of their having paid their practising certificate fees. The Council also continues to work with the Chief Justice, the Registrar of Titles and other relevant departments to ensure that persons who are not entitled to practice are not allowed to do so.

15. <u>APPLICATIONS FOR ENROLMENT</u>

Applications for qualifying certificates were received from 147 persons and approved as set out in Appendix I.

In April, 2018 the Disciplinary Committee implemented a computerised database called Curia Suite Apex (Advance Performance Exponents Inc) Case Management System (Apex Curia-Case Management System) which is a group of case management and automation solutions, specifically designed and built to automate case management activities and provide timely and accurate performance reports to improve efficiency and productivity. All complaints were scanned and uploaded unto the database and are available to be viewed via the Curia website by the staff of the Disciplinary Committee and all the members of the Disciplinary Committee.

In addition to computerizing our database, the Disciplinary Committee in April, 2018 embarked on a brand-new way of doing business whereby fixed panels were struck for a six (6) month period and cases assigned to each Panel for the period. There were eight (8) Panels and on average each panel was assigned forty-three (43) cases for the period April, 2018 - November, 2018. Between December, 2018 - 31st March, 2019 on average each panel was assigned 24 cases. The panels for the six month period from December, 2018 have two more months to go but we decided after the first six months to reduce the number of matters before each panel.

This new method of fixed panels has led to a noticeable increase in the completion of matters. Prior to the new system being implemented, and before fixed panels were introduced, for the twelve-month period from 1st April, 2017 to 31st March, 2018, one hundred and four (104) complaints were completed by the Disciplinary Committee. Since the implementation of the fixed panels three hundred and seventy-eight (378) complaints have been completed with two (2) more months left to go April, 2019 and May, 2019. We therefore have completed 263% more matters with another two months to go. Indeed, had the eighty-six (86) outstanding Decisions been delivered we would have completed four hundred and sixty-four (464) matters and would in fact have shown a 346% increase in total matters completed.

Additionally, it should be noted that for the most part all complaints for which a prima facie case was found at the general meeting now have a date for hearing except for matters filed after. Further as at the 31st March, 2019 most of the complaints before the general meeting are complaints filed in 2019.

The Disciplinary Committee's new way of business has been an adjustment for all and for some of the members and staff, the adjustment has been more challenging than for others. However, as time goes on, I have no doubt that the Disciplinary Committee will complete more of the matters with greater speed and efficiency.

However, Mr. Donaldson no longer attends the meetings, the remaining documents are usually given to Messrs. Pierre Rogers, Peter Champagnie and/or Christopher Kelman. All other members now access their documents through notebooks/laptops/computers. The Disciplinary Committee has approved certain amendments to the Legal Profession (Disciplinary Proceedings) (Amendment) Rules, 2019 specifically service by fax, email and personal service has been introduced and consolidation of complaints. The first amendment should reduce the administrative expenses going forward.

OUTSTANDING APPEALS AGAINST THE GENERAL LEGAL COUNCIL AS AT $31^{\rm ST}$ MARCH, 2019

1. Oswest Senior-Smith v The General Legal Council (exp. Lisa Palmer Hamilton) (Civil Appeal No. 6 of 2016)

This is an appeal against the general meeting's decision that there was no prima facie case for the Attorney to meet. The appeal was heard and Judgment given upholding the Disciplinary Committee's decision. Costs was awarded to the General Legal Council. Oswest Senior-Smith filed a motion to appeal the decision to the Privy Council which was dismissed by the Court of Appeal. Michael Hylton, Q.C. represents the General Legal Council.

2. Richard D. Bonner v The General Legal Council - MA No. 97/2017 (Exp. Dr. Opal Gibson-Corbin)

This appeal was filed on the 12th October, 2017 against the decision of the Disciplinary Committee to strike off Mr. Bonner off the Roll of Attorneys. A date has not yet been fixed for the appeal. Sandra Minott-Phillips, Q.C. represents the General Legal Council.

3. Gregory Lopez v The Disciplinary Committee of the General Legal Council (Paul Black) - Misc. Appeal No. 27 of 2017

The Attorney filed a Notice of Appeal on the 18th April, 2017 and Application for a stay of the decision striking him off the Roll. No date has been fixed as yet for the application. The Attorney has not prosecuted the matter. Sandra Minott-Phillips, Q.C. represents the General Legal Council.

4. Arlean Beckford v The General Legal Council (Exp. Loretta Henry Grant)

An application was filed for extension of time within which to file an appeal. When it came on for hearing on the 27th June, 2016 Ms. Beckford's Attorney applied for an adjournment to allow him time to review the file. The Registrar of the Court of Appeal by letter dated the 14th August, 2017 to Ms. Beckford's Attorney requested that he relist the notice of

application for a new date to be inserted. No date has been fixed. Sandra Minott-Phillips, Q.C. represents the General Legal Council.

5. Norman Samuels v The General Legal Council - MA 5/2016 (formerly 85/2016)

This appeal filed on the 30th August, 2016 was heard during the week of the 13th April, 2018 and judgment has been reserved. Sandra Minott Phillips, Q.C. represented the General Legal Council.

6. Harold Brady v The General Legal Council - Civil Appeal No. MA 01/2017 (Exp. Factories Corporation)

This appeal came up for hearing on the 11th October, 2017. The Court ordered that the Appellant file a Notice of Application to admit fresh evidence in relation to allegations of bias and also ordered that all of the deponents of the affidavits including the Chairman of the Disciplinary Committee Panel, Daniella Gentles-Silvera, should attend Court to be cross examined to enable the Court to determine if the Appellant's application for fresh evidence should be allowed. The matter was adjourned to the week of the 12th March, 2018 and on that day again adjourned the 16th July, 2018 due to the limited number of Judges who could hear this matter. On the 16th July, 2018 it was again adjourned as Mr. Brady's Attorney indicated that he would be making an application for the President of the Court of Appeal to recuse himself. The matter came up for hearing again on the 11th March, 2019 but was adjourned as one of the judges recused herself from the matter. The appeal has now been fixed for the week of the 28th May, 2019. Denise Kitson, Q.C. represents the General Legal Council.

7. Claim No. 2017 HCV 01211 - Abe Dabdoub and Raymond Clough v The Disciplinary Committee of the General Legal Council (exp. Dirk Harrison Contractor General of Jamaica)

An application was filed in the Court of Appeal on the 28th June, 2018 seeking leave to appeal a decision of the Supreme Court that the Fixed Date Claim Form filed as an appeal against the Disciplinary Committee's decision that there is a prima facie case to be answered, is misconceived and is an abuse of the process of the Court. Carlene Larmond

represents the General Legal Council. The Court of Appeal refused the Attorneys' leave to appeal the decision of the Supreme Court striking out the claim on the 15th November, 2018.

8. Humphrey McPherson v Disciplinary Committee of The General Legal Council (Misc. Appeal No. 2 of 2016) (Application No. 120/17) (Idela Joyce Stewart)

This matter involves an appeal from a decision of the Disciplinary Committee of The General Legal Council delivered on the 30th November, 2016 striking off the Attorney from the Roll. The appeal was in fact struck out on the 9th June, 2017 on the basis that the notice of appeal was filed out of time. Mr. McPherson subsequently filed an application for a number of orders including that a procedural appeal be heard. This appeal arising out of the same disciplinary hearing was filed in 2013 (MA No. 2 of 2012) against certain rulings by a Panel of the Disciplinary Committee made during the hearing on the 18th April, 2013. The Attorney is requesting in the application that the rulings should be overturned or alternatively that his name be restored to the Roll as an Attorney. Mr. McPherson did not pursue the procedural appeal and is now seeking to resurrect it and have it incorporated in the 2016 appeal which has been struck out. The Attorney is also seeking an order that the Order of the Court of Appeal striking out the appeal, made on the 9th June, 2017 be set aside. The procedural appeal which is to be heard on paper, is to be considered on the 27th May, 2019. Sandra Minott Phillips, Q.C. represents the General Legal Council.

9. The Disciplinary Committee of The General Legal Council (Exp. Elizabeth Hartley) v Janice Causwell - JCPC 2017/0037

On the 11th March, 2019 the Privy Council handed down its judgment allowing the General Legal Council's appeal. The Privy Council held that a complaint filed by an agent on behalf of a complainant who ratifies the agent authority to bring the complaint after the complaint was filed may be subsequently ratified. Michael Hylton, Q.C. and Carlene Larmond represented the General Legal Council.

10. Michael Lorne v The General Legal Council - Misc. Appeal No. 3 of 2017

This is an appeal filed by Michael Lorne against a decision striking him off the Roll. The appeal has been fixed for the 10th June, 2019. Sandra Minott-Phillips, Q.C. and Litrow Hickson represent the General Legal Council.

11. Don Foote v The Disciplinary Committee of The General Legal Council (Amy Robinson) (Miscellaneous Appeal No. 2 of 2018)

Mr. Foote filed an appeal against a decision of the Disciplinary Committee which sanction included a fine of \$1,000,000.00 to be paid on or before the 24th May, 2018 failing which Mr. Foote was to be suspended from practice for one (1) year. Mr. Foote paid the fine within the stipulated period. The appeal has been fixed for the week commencing the 20th May, 2019 but the appellant has failed to comply with the Case Management Conference orders and therefore the General Legal Council's Attorney has filed an application for the appeal to be struck out. The General Legal Council is represented by Sandra Minott-Phillips, Q.C. and Litrow Hickson.

12. Eileen Boxill v Jennes Vashti Anderson (a member of the General Legal Council - SCCA No. 941 of 2012 consolidated with Miscellaneous Appeal No. 3 of 2014

The appeal was successful and the decision of the Disciplinary Committee sanctioning the Attorney for failure to file statutory declarations under the Accounting Regulations was set aside and costs awarded to the Attorney. The costs are being taxed. Mrs. Denise Kitson, Q.C. represents the General Legal Council.

13. Howard Lettman v The Disciplinary Committee of The General Legal Council (Rudolph Campbell) - Appeal No. 1 of 2018

This appeal was filed on the 9th January, 2018 against an Order given on the 1st December, 2017 suspending the Attorney from practice. On the 5th November, 2018 Mr. Lettman filed a Notice of Abandonment of the Appeal. Carlene Larmond represented the General Legal Council in the appeal.

14. Ian H. Robins v The General Legal Council (Miscellaneous Application No. 6 of 2018)

An appeal was filed against a striking off order of Mr. Robins for breach of the Legal Profession (Accounts and Records) Regulations on the 17th May, 2018. The Attorney applied for a stay which was granted on the 29th November, 2018 on the condition that the Attorney's practice be limited to one case **R v Missick**. The appeal has been fixed for the week commencing the 10th June, 2019. The General Legal Council is represented by Carlene Larmond.

15. George Jeffrey v Leroy Equiano (Miscellaneous Application No. 7 of 2018)

This appeal was filed on the 22nd May, 2018 by the complainant in person against a decision of the Disciplinary Committee dismissing the complaint. The General Legal Council is represented by Carlene Larmond.

16. Minette Lawrence v The General Legal Council (SCCA No. 64/2018)

This appeal was filed on the 13th June, 2018 against a finding of professional misconduct and an order striking off Mrs. Minett Lawrence off the Roll of Attorneys. An application for stay was filed but withdrawn by the Appellant on the 20th November, 2018. The appeal is fixed for the week commencing the 10th June, 2019. The General Legal Council is represented by Hugh Small, Q.C. and Trudy-Ann Dixon Frith.

17. Richard Retzin v The General Legal Council (exp. Girvan Williams) MA 10/2018

This appeal was filed on the 19th July, 2018 against a panel's (Disciplinary Committee) decision given on the 14th July, 2018 not to recuse themselves from hearing a complaint. The Attorney, Richard Retzin alleges that the Panel members are biased. This appeal was fixed for the week commencing the 4th March, 2019 but on the 8th January, 2019 the Attorney withdrew the appeal and costs to the General Legal Council was agreed at \$150,000.00. The General Legal Council was represented by Sandra Minott-Phillips, Q.C. and Litrow Hickson.

18. Jerome Dixon v The Disciplinary Committee of the General Legal Council - Civil Appeal No. 109 of 2018

This appeal was filed on the 15th November, 2018 against a decision striking the Attorney off the Roll for breach of an undertaking. An application for a Stay was filed but no date has been fixed. The General Legal Council is represented by Mr. Michael Hylton, Q.C.

19. Jennifer Messado v The Disciplinary Committee of the General Legal Council (Elise Wright Goffe) (Miscellaneous No. 11/2018)

An appeal was filed on the 12th October, 2018 by Mrs. Messado against an order of the Disciplinary Committee of the General Legal Council striking her off the Roll. The General Legal Council is represented by Sandra Minott-Phillips, Q.C.

20. Gorstew Limited v General Legal Council (Garth McBean) (Miscellaneous Appeal No. COA 2019 00012)

This appeal was filed on the 1st February, 2019 by Gorstew Limited against an order of the Disciplinary Committee of the General Legal Council dismissing the complaint. The General Legal Council is represented by Mr. Michael Hylton, Q.C.

21. Gorstew Limited v General Legal Council (Raymond Clough) (Miscellaneous Appeal No. COA 2019 MS00002)

This appeal was filed on the 21st February, 2019 by Gorstew Limited against an order of the Disciplinary Committee of the General Legal Council dismissing the complaint. The General Legal Council is represented by Mr. Michael Hylton, Q.C.
