#### INTRODUCTION

The General Legal Council was established in January 1972 by the Legal Profession Act. Its statutory function is concerned with the legal profession and in particular the organization of legal education and the upholding of standards of professional conduct. By virtue of the Legal Education Act, the Council's function as the Legal Education Authority is vested in the Council of Legal Education which is established by Agreement among several Commonwealth Caribbean countries.

Apart from Law Officers of the Crown and legal officers of Government who are *ex officio* entitled to practise as such, no person can lawfully practise as an attorney who does not hold a practising certificate issued by the Council. Practising Certificates are issued annually on satisfying certain requirements, including the payment of an annual fee.

The Council is required to appoint from among its members or former members, Judges or retired Judges and attorneys of not less than ten (10) years standing, the Disciplinary Committee which adjudicates on complaints of misconduct by attorneys in any professional respect.

The Council is authorized to make rules prescribing the standards of professional etiquette and professional conduct for attorneys and to direct that any specified breaches of such rules constitute misconduct in a professional respect.

#### **CHAIRMAN'S MESSAGE 2022**

On the 24<sup>th</sup> April 2022, Allan Wood QC demitted the chairmanship of the General Legal Council. The Council extends its heartfelt thanks to Mr Wood for his sterling and enlightened leadership, particularly while appearing as lead counsel in the challenge by the Jamaican Bar Association to the anti-money laundering reporting and monitoring regime applicable to attorneys under the Proceeds of Crime Act and the AML Guidance issued by Council. The Court of Appeal having found that aspects of the same contravene the Constitution. Mr Wood will lead a team representing the Council on an appeal to the Judicial Committee of the Privy Council slated to be heard later this year.

As has obtained since the onset of the Covid 19 Pandemic, the Council has maintained its reliance on video conferencing for the holding of meetings of Council, its subcommittees, CLPD seminars as well as Disciplinary Committee hearings..

To further ameliorate the dislocation that continues to be experienced by attorneys, as a result of the Covid-19 Pandemic, Council proposes to continue to make available in the ensuing month, a number of CLPD seminars free of cost to assist attorneys in complying with the mandatory CLPD requirements. Council's operations have been maintained without seeking an increase in practising fees, which have been maintained at the same level for the last six years. The matter will be reviewed in the coming months.

It has been early days yet since the coming into effect on the 1<sup>st</sup> day of January 2022 of the Legal Profession (Accounts and Records) (Amendment) Regulations 2021 (the Amended Accounting Regulations 2021). Its effect will likely be evident by the end of the financial year 2022-2023.

The Welfare Fund Committee now led by Mr Donovan Walker, since the untimely passing of Mr Nathan Robb, has worked assiduously to provide draft legislation to the office of the Attorney General for their consideration. We await the implementation of the same.

I would like to thank the staff, all members of the General Legal Council and members of the subcommittees for their continuing support and commitment to the advancement of the Legal Profession.

6. ACCREDITATION COMMITTEE

1. During the period, April 2021 – March 2022, the Committee received a total of 39 new

applications from institutions for accreditation of courses to be presented by them.

2. There were 112 applications for exemptions, 111 applications from individuals for credits

for activities in which they had participated and 13 applications for extension. Of the total

of 275 applications which were reviewed during the period, 138 applications were

successfully addressed, 33 were refused, and 104 were granted extensions.

3. The data also discloses that during that period, of a total number of **2,764** attorneys, **679** 

are fully compliant in their participation in CLPD programmes; 393 have sufficient credits

awarded for compliance but the filing of the Form 3 remains outstanding and 1587 are

partially compliant. Attorneys have until November 2022 to become fully compliant. 1

attorney received an exemption and **104** received extensions.

4. The Accreditation Committee is pleased to report that as anticipated, consequent on the

conferral of provider status on the General Legal Council, the Jamaican Bar Association

and the Faculty of Law of the University of the West Indies there continues to be significant

reduction in the number of applications to be reviewed and processed. The Committee has

implemented the requisite monitoring procedures and has required strict compliance with

the same by the Continuing Legal Professional Development Committee of the Accredited

Providers.

5. This Report would not be complete without acknowledging the tragic passing in February

2022 of our former member, Mr Donovan Jackson who gave sterling and unstinting service

to the Accreditation Committee. May his soul rest in peace and may he rise in Glory.

#### 7. INFORMATION TECHNOLOGY COMMITTEE

During the financial year April 1, 2021 – March 31, 2022, the General Legal Council continued to retain the consultancy services of Ms. Bertina Macaulay and Mr. Sean Williams to handle its Information Technology requirements.

In addition, Mr. Ackeem Anglin, IT administrative assistant has increased considerably the level of in-house IT support provided, which has significantly reduced the Council's dependence on the external consultants.

Ms. Macaulay's responsibilities included the following software related issues:

- i) Maintenance of the Council's website;
- ii) Improvement in the functionality of the database;
- iii) Management and maintenance of internet and email connectivity;
- iv) Providing statistical and analytical reports;
- v) Securing licences for the operating systems;
- vi) Sourcing and installing software upgrades.

Mr. Williams' responsibilities covered hardware and networking matters:

- i) Supply, installation and maintenance of servers, computers and other IT related equipment;
- ii) Maintenance and upgrading of the internal IT network;
- iii) Anti-virus software support;
- iv) Liaising with third-party providers e.g. FLOW, QUICKBOOKS, ZOOM etc.;

During the financial year under review, the General Legal Council's information technology operations were enhanced as follows:

i) Continued application of the CURIA Court Management Software to significantly improve the Disciplinary Committee's administration, documentation and case management activities; this has assisted in substantially reducing the backlog of outstanding disciplinary matters;

- ii) Continued use of laptop computers by the Disciplinary Committee's administrative staff to prepare verbatim notes of evidence at all Disciplinary Committee hearings therefore resulting in a marked improvement in the accuracy and delivery time of the notes of evidence related to the disciplinary hearings;
- iii) Integration of teleconferencing and video link facilities for Council meetings, various sub-committee meetings and Disciplinary Committee hearings which has facilitated Council and committee members, attorneys and complainants to attend either the meetings, or the disciplinary hearings, virtually.
- iv) Since March 2019, all CLPD seminars have been streamed live via the internet.
- v) In addition, each of these CLPD seminars is recorded and stored in the Cloud and are therefore available to be viewed on demand.

In an effort to significantly improve and upgrade the efficiency and effectiveness of the Council's operations, the Committee intends to address the following IT-related issues during the 2022/2023 financial year:

- 1. Creation of an interface so that applications for enrolment can be directly entered to the Council's database by the applicant;
- 2. Integration of direct deposits to the Council's bank accounts with the GLC's database;
- 3. Reassessment of the Council's cyber security measures;
- 4. Clarification of copyright issues with third party providers;
- 5. Implementation of electronic signatures;
- 6. Revaluation of the requirement for Attorneys to submit a Form 3 to verify participation in GLC's CLPD seminar, once the data is automatically uploaded to the GLC database;
- 7. Assignment of a unique login number for each Attorney to facilitate online interface with the GLC;
- 8. Digitization of enrolment applications.

#### 8. PROTECTION OF CLIENTS' ASSETS COMMITTEE

The following comprise the matters that have been addressed or are being addressed by the committee:

#### Mrs. Lanza Turner-Bowen:

• The files of Mrs. Lanza Turner Bowen were reviewed by Ms. Deanna McFarlane and Ms. Toni-Ann Smith, Attorneys-at-Law who were employed to review the files of Mrs. Turner-Bowen. It was a necessary task as these files came without an index or accounting reports. An excel sheet was created with a listing of all files in the Council's possession with contact numbers and addresses if they appear on the file. This exercise assisted us to ascertain what

we have in our possession and it has made it easier for the committee to return files to her former clients when called upon to do so. It also allows us to be more pointed in our efforts to have these files returned to clients.

- The matter was referred to the Office of the Supervisor of Insolvency for consideration 'whether the Government Trustee could be appointed as Trustee for the estate of Lanza Turner-Bowen and the Supervisor thereafter undertake administration'. However, the Supervisor of Insolvency, has offered grounds upon which he believes he is not the appropriate body to administer the client files.
- Further advertisements were published on January 28, 2020 and February 2, 2020 in the Gleaner and Observer Newspapers and Clients continue to claim files which are returned.
- The following funds were received from Sagicor Bank and Harrison and Harrison, Attorneys-at-law:

#### **Sagicor Bank:**

- 1. One Hundred and Seventy-Five Thousand and Ninety-One Dollars, Ninety-Four Cents (J\$175,091.94)
- 2. Three Thousand Four Hundred and Thirty-One Dollars and Sixty-Three Cents (US\$3,431.63)

#### Harrison and Harrison, Attorneys-At-Law:

3. Two Hundred and Fifty Thousand Dollars (J\$250,000.00) from Harrison & Harrison, Attorneys-at-Law.

The Council held a total of Nine Hundred Thirty-nine Thousand, Eight Hundred and Thirty-six Dollars and Forty-four Cents (\$939,836.44) in a trust account operated by the Council.

• The Council received monetary claims in the amount of **Twenty Seven Million**, **Four Hundred Thirty Eight Thousand**, **Six Hundred Forty Seven Dollars** (**J\$27,438,647.00**), which was significantly in excess of the sum collected from the deceased's clients' account. Below is a list of the monetary claims and the nature of each claim.

- As a result, the Council applied to the Supreme Court for directions. On November 30, 2021, the Honourable Mrs. Justice A. Lawrence Grainger (Ag) made the following Orders:
  - That the Council makes equal payments in the amount of One Hundred and Fifty Six Thousand Six Hundred and Thirty nine dollars and forty cents (\$156, 639.40) to each former client of Mrs. Lanza Turner-Bowen who has submitted monetary claims against the sum of nine hundred thirty-nine thousand, eight hundred and thirty-six dollars and forty-four cents (939,836.44), being held in trust for former clients.
  - That the unclaimed client files of Mrs. Lanza Turner-Bowen (Deceased) that are closed be destroyed immediately.
  - o That the unclaimed client files of Mrs. Lanza Turner-Bowen (Deceased) that are opened in respect of incomplete transactions be retained by the Council for a period of nine years ending on or about the 15th day of December 2027, and thereafter the Council is at liberty to destroy all such files.
  - o In compliance with paragraph one above, each of the former clients is to be served with the Fixed Date Claim Form, Affidavits and Order filed in the matter.
- The Council has since made payments to all the claimants listed above.
- Further, the cost to the GLC to administer this intervention has amounted to approximately one million dollars (J\$1,000,000.00).

#### **Henry Charles Johnson:**

- The Council was advised by Mr. Marc Morgan, Attorney-at-Law, while Mr. Johnson was alive but incapacitated to operate his firm, that he had an agreement with Henry Charles Johnson & Co. to have conduct of select real estate matters on a revenue sharing basis. He further advised that various matters for the law firm are currently being handled by third party attorneys on a similar revenue sharing or hourly basis. However, since the death of Mr. Johnson, we have not been able to get in touch with Mr. Morgan.
- Lori-Ann Tugwell wrote the Council on the 28<sup>th</sup> September, 2021 to advise that Miss Robyn Patrick asked her to take control of a number of files she listed in the correspondence. Subsequently, due to a change of employment, Miss Tugwell advised that the files given to her were returned to Miss Robyn Patrick, Office Manager for the firm.
- Robyn Patrick advised that she will be sending us details of the steps that were taken to deal with client property as a result of the incapacity and subsequent death of Mr. Johnson. However, we have not received this information, despite multiple attempts to contact her.
- Jacqueline Hamilton, mother of Robyn Patrick, was reportedly involved in the firm, by providing bearer services. She also advised that she would provide information that she knows in writing, but phone calls to Miss Hamilton since this conversation has been futile.
- Avonia Pinnock, Attorney-at-Law, was an associate who worked with Mr. Johnson. Subsequent to his death, she has since resigned from the firm. She advised that many of the clients opted to have her complete transactions previously being carried out by the firm. To prove this, she has sent us agreements she now has with these clients and a notice of change of attorney re matters that are in court.
- Thus far, there has been no complaint to the Council by any client that they have not been able to obtain their file or other property or that they are dissatisfied with the failure to deal with their matter.

#### **Paul Beswick:**

• The estate and the firm Harbour Law, trading as a sole proprietor under the name 'Ballantyne, Beswick & Company' are being represented by Mr. Ashford Meikle, Attorney-at-Law.

- Executors of the estate are Angel Beswick-Reid and Katherine Pinnock. Mr. Meikle
  advised that Harbour Law does not play a role in the files of the former clients of the
  deceased. Files are secured at 103 Harbour Street and once a client contacts his firm, the
  file is handed over upon payment of any outstanding fees owed to the defunct firm,
  Ballantyne, Beswick & Company. The fees form part of the estate of the deceased.
- The firm Ballantyne Beswick & Company maintained accounts at First Global Bank and National Commercial Bank. First Global provided access to the accounts and monies have been paid to clients but access has not been gained to NCB.
- There appears to be proper arrangements in place for the protection and return of clients' assets.
- The Executors sent Duplicate Certificates of Titles to the Council for safe keeping on the 17<sup>th</sup> of September, 2021, belonging to former clients of the deceased's attorney. The titles are still in the Council's vault.

#### Norma Greig-Miller:

• This matter is currently being investigated by the Council to determine whether it will intervene.

#### **Other Matters:**

It has been brought to our attention that the following Attorneys died during the period under review, however, there has been no forthcoming claims requiring an intervention:

#### 9. ACCOUNTING REPORTS COMMITTEE

During the year under review the Committee did the following:

- a) Considered policy issues raised by attorneys and reviewed the Legal Profession (Accounts and Records) Regulation, 1999 (the "Accounts and Records Regulations") in order to provide guidance to management regarding the interpretation of the Regulations or the policy of the GLC towards the issues raised;
- b) Reviewed and responded to requests for exemptions and extensions;
- Engaged with the Jamaican Bar Association and the Cornwall Bar Association regarding proposed amendments to the Accounts and Records Regulations which took effect on the 1<sup>st</sup> of January 2022;
- d) Discussed suggestions to improve the efficiency of the Investigations Division of the Council;
- e) Discussions concerning the status of the Norman Manley Legal Aid Clinic vis-à-vis the Accounts and Records Regulations.

Accountant's reports or declarations are generally due by June 30 each year for the preceding calendar year (unless an attorney has a different 12- month period as his/her financial year). For most attorneys, therefore, the filing of accountant's reports or declarations are not yet due for the year 2021.

To date, the average percentage compliance for the years 2000-2020 is 97.28 %. Compliance for financial year 2019, is currently at 82.38%. and 2020 is 78.92%. We continue to receive accountant's reports and declarations with respect to 2021 and previous years and anticipate that persons will make an effort to file reports or seek extensions before the end of the year to avoid being unable to obtain their practicing certificate for 2023.

The Accounts and Records Regulations empowers the GLC, where it is satisfied that the circumstances warrant it, to grant extensions of time to comply with the Accounts and Records Regulations. Additionally, the Accounts and Records Regulations also empowers the GLC to grant exemptions from the requirements under the Accounts and Records Regulations for the delivery of an accountant's report or declaration to attorneys who are exclusively employed outside Jamaica for the period of such employment outside Jamaica.

During the period April 1, 2021 to March 31, 2022 there have been fourteen (14) applications for extensions of time which have been granted and seventeen (17) applications for exemptions which have been granted.

Pursuant to Regulation 16(6), the GLC withheld the issue of a practicing certificates to eight (8) attorneys who failed to comply with the Accounts and Records Regulations. Five (5) attorneys have since become compliant.

During the period April 1, 2021 to March 31, 2022 <u>no</u> new complaints were laid against attorneys for failure to comply with the Accounts and Records Regulations.

#### 10. FINANCE AND ACCOUNTING COMMTTEE

The Finance and Accounting Committee continued to guide, support and strengthen the Council's financial activities during the period April 1, 2021 – March 31, 2022.

The committee continued to provide proper, comprehensive and rigorous supervision and direction, specifically in matters concerning expense containment, financial transactions and prudent investment opportunities.

Among the many significant contributions made by the Committee during the period under review, was to guide and assist the Chief Executive Officer to prepare the Council's annual revenue and expense budget for the financial year April 2021 – March 2022.

Having recognized the island's continuing adverse financial and economic conditions of the international coronavirus pandemic, the Committee provided comprehensive and sound guidance and assistance for casting the Council's revenue and expense budget.

The Finance and Accounts Committee also periodically monitored all financial inflows and outflows in accordance with the budgeted provisions, therefore ensuring that the Council's finances were carefully administered.

The Committee maintained a close working relationship with the Chief Executive Officer and by extension with the Council's external auditor to ensure that the Council's operational and reporting standards continued to be in line with the established accounting, financial and administrative procedures.

The Committee periodically monitored the Council's bank accounts and the associated commercial bank transactions and recommended specific short, medium and long term investment opportunities.

The members of the General Legal Council's Finance & Accounting Committee during the 2021/2022 financial year were Attorneys-at-Law, Messrs. Lowel Morgan (Chairman), Richard Ayoub, Stuart Stimpson, Stephen Shelton QC, Donovan Walker and a Chartered Accountant, Ms. Paula Turner.

# 11. <u>CONTINUING LEGAL PROFESSIONAL DEVELOPMENT (CLPD ) COMMITTEE</u> <u>INTRODUCTION</u>

- 1. The annual report concerns the activities of the CLPD Committee of the General Legal Council for the period April 1, 2021 to March 31, 2022. In keeping with the objectives of the CLPD Committee to provide quality continuing legal education courses to attorneys in Jamaica, this report contains an account of the courses offered during the year under review and the participation of attorneys in these courses. It also contains aspirations of the committee to improve the customer experience of the attorneys and the impact of the courses.
- 2. April 1, 2021 marked the commencement of the ninth (9<sup>th</sup>) year that the CLPD Committee has been serving members of the legal profession in this capacity. The CLPD Committee of the General Legal Council was established in 2013 and has been offering courses in

Continuing Legal and Professional Development since February 18, 2013. The Committee was chaired by Dr. the Hon. Lloyd G. Barnett between 2013 and 2015. He was succeeded by the Hon. Mr. Justice C. Dennis Morrison, who served as Chairman until December 2020. In January 2021 Miss Gillian Burgess assumed the chairmanship of the Committee.

3. The Committee aims to meet at least once per month during term time and has from time to time met more frequently as the need has arisen. The full membership of the Committee for the year 2021-2022 is shown in Appendix A.

#### **FUNCTIONS**

- 4. The scope of the Committee's work is:
  - To design and present courses for the purpose of the continuing legal professional development of Attorneys-at-law;
  - ii) To arrange programmes for the delivery of CLPD seminars on an island wide basis;
  - To ensure that there are adequate offerings in Ethics and Client Welfare,Business Management and Finance.
- 5. In carrying out its functions, the CLPD Committee encourages the conduct of research in the preparation of papers on a variety of legal subjects. In the relevant period the Committee presented papers on topics such as Contracts, Conveyancing, Company Law, Regulatory Requirements, Employment Law, Banking and Finance, Dispute Resolution. Regarding the mandatory requirements for presentations in Ethics and Client Welfare, Business Management and Finance, the Committee has also sought to ensure that there have been adequate offerings in these subjects.
- 6. Since March 2019, the Committee has been facilitating access to selected seminars using the internet. As a result of the restrictions on gatherings occasioned by the COVID-19 pandemic, the CLPD Committee courses were offered exclusively online. A total of Fifty-

One courses were offered by Zoom – a cloud-based videoconferencing software that permits virtual meetings. Four(4) courses were offered at no cost to the participants in June 2021 to ensure that attorneys could complete their CLPD requirements despite the financial hardships which resulted from the economic contraction caused by the COVID-19 pandemic and as an expression of gratitude for the support of the profession as we strive to improve. On October 28, 2021 the GLC partnered with the CCJ Academy for Law to put on a cross jurisdictional panel which was offered at no cost to the participants. On December 10, 2021 the GLC partnered with the Independent Jamaican Council for Human Rights (1998) Ltd to put on a seminar in recognition of International Human Rights Day.

- 7. The topics, number of presentations and number of attorneys who attended these seminars are presented in Appendix B. There has been a total of 13,058 registrations by attorneys for these seminars.

#### RETURN TO IN-PERSON SEMINARS

8. The general feedback is that attorneys enjoy being able to access courses virtually and on demand. Virtual seminars offer flexibility to the participants, the presenters, and the host. They also eliminate the costs of venue rental and transportation. Notwithstanding those benefits, in-person seminars offer an opportunity for attorneys to connect with each other and to learn from each other in ways that virtual seminars do not. Informal interactions build relationships that are important for professional development. The benefits of meeting face-to-face are qualitative and therefore difficult to quantify. By contrast, the benefits of meeting virtually are quantitative. Consequently, it is hard to compare on-line learning with face-to-face learning for adults. At this juncture, it is difficult to say whether there will be a return to in-person seminars in the immediate future.

#### **FINANCIAL CONSIDERATIONS**

- 9. Despite the challenges, in the relevant period the CLPD Committee continued to generate revenue in excess of its expenditure. Over this period the net contribution of the Committee to the Council's coffers was approximately J\$39.5 million. A financial report showing the income and expenditure of the Committee over the period March 2013 to March 2022 is attached as Appendix C.
- 10. The relatively low cost of delivering 51 seminars over the relevant period is accounted for by the following:
  - The comparatively low cost of delivering webinars using zoom
  - Members of the CLPD Committee donate their time to the Council in planning a schedule of seminars for the year
  - Members of the CLPD Committee assist in the selection of topics and presenters
  - Members of the CLPD Committee prepare and present papers
  - Members of the CLPD Committee donate their time to review papers to ensure that they meet the required standards
  - Presenters donate their time without a fee in the research, preparation, and presentation of the seminar papers

- Staff at the Council undertake the responsibility of advertising the seminars through email and other means
- 11. The major costs associated with the programme usually relate to the rental of venues, provision of refreshments, accommodation of presenters and staff members for seminars held out of town, and administrative costs. Most of these costs were eliminated.
- 12. It should also be observed that the number of registrants for seminars increased over the previous period. This accounts for the improvement in the net contribution to the coffers of the Council. This is undoubtedly, the result of the hard work of the members of staff, the Committee and the presenters who volunteered their time to research, prepare and present papers.
- 13. Nevertheless, the Committee is cautious in its expectation for the sustainability of this high level of income. In order to continue to attract the support of the profession, the CLPD Committee must produce seminars which engage the interests of the attorneys while adding value to their practice.

#### <u>Utilisation of Electronic Technology:</u>

- 14. On March 10, 2019 the CLPD Committee facilitated its first seminar using an online platform. Since then, the facility became more critical because of the measures put in place by the Government of Jamaica to limit the spread of Covid-19. Courses are now offered exclusively online. In addition to the question and answer and chat features in the webinar, attorneys are invited to submit questions and feedback using email. The Committee continues to explore the use of technology to engage the interest and participation of attorneys.
- 15. As part of its mandate to increase efficiency in communication, the Committee has implemented electronic processing of Certificates of Participation which are sent via email and are automatically generated through the GLC's database. Soft copies of seminar papers are also distributed by email to the attendees.

#### THE WAY FORWARD

16. The CLPD Committee is fortunate to have benefited from the wealth of experience of senior practitioners who graciously lend their time and effort to the preparation and delivery of interesting seminars. The Committee is keen to nurture young talented attorneys to use their voices to effect change and has been pleased to give a platform to young counsel who wish to speak on issues of law which resonate with them. It is also important to continue evaluating the methods of delivery and the use of technology to deliver seminars. The Committee aims to ensure that the process is seamless from registration to evaluation.

#### TRIBUTE TO MISS NANCY ANDERSON

17. The Committee mourns the passing of Miss Nancy Anderson who served on the Committee since its inception. Miss Anderson passed away on November 29, 2021, a few weeks shy of her 75<sup>th</sup> birthday. Miss Anderson believed deeply in the transformative power of education and the importance of passing on knowledge to the next generation of attorneys. Miss Anderson was a vivacious person who helped many people in her community. She was tireless in her advocacy on behalf of the less fortunate and never shied away from difficult tasks. She will be missed.

#### **CONCLUSION**

- 18. The Committee is immensely grateful to those attorneys who have voluntarily prepared and presented papers during the year under review as well as those who have undertaken to make further presentations.
- 19. The Committee continues to express its gratitude to the GLC's administrative staff who have assisted with the successful delivery of the CLPD programme over the year under review.
- 20. The Committee is particularly grateful to Mr Ian Jackson, the GLC's CEO, Miss Tanya Ferril, the CLPD Coordinator, Ms. Kenisha Millier, the Junior Administrative Assistant,

- and Mr. Ackeem Anglin, the Information System Coordinator, who provided crucial support over the entire period.
- 21. As the Committee looks ahead it will need to consider the expansion and diversification of subject areas to maintain attorneys' interest and encourage greater participation. This will also involve exploring the need to engage experts from related disciplines and the question of the costs which may be associated with the engagement of such persons.

The Council has published on its website, a list of attorneys who are entitled to practise by virtue of their having paid their practising certificate fees. The Council also continues to work with the Chief Justice, the Registrar of Titles and other relevant departments to ensure that persons who are not entitled to practice are not allowed to do so.

#### 13. <u>APPLICATIONS FOR ENROLMENT</u>

Applications for qualifying certificates were received from 176 persons and were approved as set out in Appendix I.

#### **Chairman's Message**

The Disciplinary Committee continued to conduct most of its hearings during this period by Zoom.

We expect to resume in person hearings in the new term in September 2022.

As of the 1<sup>st of</sup> April 2022, there were 190 pending complaints which include 35 part heard matters and 80 for which Judgments have been reserved. This is a marked reduction in the number of outstanding complaints as compared to the period 2016 to 2017 which was just before the changes were introduced with respect to the functioning of the Disciplinary Committee. At the end of the period 2016 to March 2017 there were 720 outstanding complaints. The reduction in the number of complaints outstanding has been due to a large extent to the changes in how the Disciplinary Committee functions, such as panels are fixed, and the same members sit together for 6 months at

a time. Further we now have our own case management data base on which all complaints are uploaded, and each file is updated in real time. The reduction in the number of complaints is also due to the fact that more Attorneys are responding to complaints from the outset before they are set down for hearing, consequent upon which there has been an increase in the number of matters which are dismissed on the basis that the complainant has shown no prima facie case. It has also been observed that fewer complaints have been filed over the last 2 years no doubt due to the Covid 19 pandemic.

The Disciplinary Committee would like to express our appreciation to the General Legal Council for its support for all the changes which has been introduced by the Disciplinary Committee and in particular we wish to thank the former Chairman of the General Legal Council, Mr. Allan Wood Q.C, who initiated discussions with Sir Dennis Byron, former President of the Caribbean Court of Justice, with a view to introducing a case management computer system for the Disciplinary Committee to assist with reducing the backlog which was facing the Committee at that time.
